All tuition and fees must be paid before registering for classes. Incomplete payment of tuition and fees may result in a hold being placed on your account, possible disenrollment and forfeiture of tuition fees already made.

Cash and check payments can be made in person at the Cashier's Office, Administration Building, Room 128. Check payments must be made payable to CSULA. Please write your CIN on your check payment. Your full payment will allow you to register on the same day, if it is your scheduled appointment date on GET.
