A student's registration process is not considered complete until all required fees have been paid. Failure to pay fees in full may result in a hold being placed on your account, possible disenrollment and forfeit any money already paid.

If not paying by SMARTPAY, submit your completed Fee Analysis form with **check or money order payment payable to CSULA**. **Please write your CIN on the payment**. Check payments must be submitted by U.S. mail or at the Cashier's Office drop slot outside Administration Building, Room 128. Cash payments must be made at the Cashier's Office Window. If paying by cash at the Cashier's Office or credit card on SmartPay, you may register for classes one business day after payment. **Check payments must be received by the Cashier's Office three business days before registering for classes**.
