Attach copy of dependents' passport biographical page.
- **Change of Major**-the information must be updated in GET prior to issuance of new I-20. If you have been at Cal State L.A. for more than one year, you must provide new original financial documents/affidavit.
- **Program Upgrade**- the information must be updated in GET prior to issuance of new I-20. New original financial documents/affidavit is required.

The fees are subject to change. Married students who are accompanied by a spouse and/or children must show additional funds of \$4,500 for the spouse and \$3,000 per child for one academic year (nine months).

- ✓ Saving or Checking account
  - ✓ Certificate or Time Deposits with the maturity date in the future
  - ✓ Letter of financial support or financial guarantee document from government sponsors or foreign embassies which specific CSULA as the student's school, and validity period of financial support
  - ✓ Official scholarship award letter
- If you will use your own **personal funds**, you must provide a bank statement dated **within the last 6 months** or complete the Bank Certification.
  - If you will be supported by a **private sponsor** (family member, friend, or private institution), the sponsor must sign the Sponsor Information and provide proof of finances by submitting a bank statement or completing the Bank Certification.
  - If you will be sponsored by a **public agency** (embassy, home government, public institution, religious organization), the agency must provide written verification of the term and amount covered.
