



Field Placement Process

Fall & Spring Semesters of Senior Year

- Integrative Field Seminar: SW 4951 (Fall semester) and SW 4952 (Spring semester)
- Complete 420 hours of an internship in a social service agency
 - Must have daytime availability ;2 full days (14 hours) per week ; no evening weekend or virtual field placements available. Vaccinations required





Summer Intensive Program (SIPP)

- Students who graduate in the summer when the field internship is the only requirement left for them.
- SW 4951 & SW 4952 during the summer semesters; Complete 400 hours of an internship in a social service agency (No DCFS or Probation Internships available)



Must have daytime availability ;5 full days (40hours) per week

Students with background issues are NOT eligible for the summer internship (they) maybe able to complete their field internship during the academic year).

Field Internship Eligibility


I. PREREQUISITES

- Pass (with a C or better grade*): SW 3010*; SW 3700*; SW 3720*; SW 3711;
- & SW 3712

- Complete minimum of 90 units by the end of the Spring before entering field
- in the Fall
 - Approval from an academic advisor for completion of required courses
 - Be in the final semester of my senior year in social work major
 - Have a minimum of 2.0 GPA (grade point average).
- ***YOU ARE ELIGIBLE TO APPLY FOR YOUR FIELD INTERSHIP PLACEMENT!!!
