The President's statement reads: "I am returning the above titled proposed policy unsigned. This is a benefit that is reserved for faculty who are granted Emeritus status."

	"In the response to the Intent to Raise Questions Memo dated October 12, 2006 (originally addressed to Vice President Quan) Senator Anagnoson asked:	
	Will the University be providing any GET adviser training this year?	
	"GET training will continue for advisers and departments based on the recommendation of the Associate Deans and Department Chairs. The original 'train the trainer' model used to train academic advisers is still in place and faculty are encouraged to contact their department chair for more details.	
	"Additionally, an email was sent to Associate Deans on September 22 announcing the reorganization of the Graduation Office which resulted in the assignment of an evaluator to each college to provide graduation check/advisement support to faculty and staff. If an adviser or staff member needs help regarding a student's grad check, entering course substitutions, electives or assistance reading grad check results, they can contact an evaluator assigned to their College. Faculty are encouraged to contact their chair or associate dean for more information.	
	"I trust my response addresses Senator Anagnoson's question."	

ANNOUNCEMENTS (Continued)	1.1.7 On April 11, 2006, the Academic Senate approved a proposed policy on Class Size and Student Enrollment. On July 27 th President Rosser returned the policy unsigned and submitted substitute language for consideration. In July the Executive Committee referred the returned policy and the substitute language to the Faculty Policy Committee. At its meeting of November 2, 2006, the Faculty Policy Committee concurred that the proposed substitution is not in the spirit of the original document and rejected it.
