- 5. 5.1 It was m/s/ (Cleman) to amend lines 10 and 11 of document 06-15 by deleting the words have maintained a grade point average adequate and inserting the words MEET THE MINIMUM REQUIREMENTS.
  - 5.2 Debate ensued.
  - 5.3 The Cleman motion was withdrawn.
  - 5.4 It was m/s/ (Sharp) to amend line 8 of document 06-15 by deleting the words apply toward graduate credit and inserting the word TAKE, and to amend lines 11 and 12 by deleting the words in which the master's degree is to be taken and inserting the words TOWARD WHICH THE COURSES WOULD NORMALLY BE APPLIED.
  - 5.5 Debate ensued and Senator Sharp suggested that her motion include adding the following sentence after the word "applied:" IF THE STUDENT IS ADMITTED TO THAT PROGRAM AS A GRADUATE STUDENT, THESE COURSES MAY BE APPLIED TOWARD THAT DEGREE.
  - 5.6 It was agreed by consensus to accept the additional language suggested by Senator Sharp as part of the original motion.
  - 5.7 Debate continued and it was agreed by consensus to amend the new sentence proposed by Senator Sharp by deleting the phrase <u>these courses may be applied</u> <u>toward that degree</u> and inserting the phrase THE STUDENT MAY PETITION TO HAVE THOSE COURSES APPLY TOWARD THAT DEGREE.
  - 5.8 It was m/s/p (Falvey) to refer the document back to the Educational Policy Committee for reconsideration and to include in the referral the motions made at the Senate meeting.
  - 5.9 Associate Vice President Cash requested Educational Policy Committee be asked review the use of the term "Chair" in regard to a "program."
- 6. 6.1 It was m/s/ (Cleman) to table document 06-16.
  - 6.2 A brief debate took place and the Cleman motion was withdrawn.
  - 6.3 It was m/s/ (Flint) to amend document 06-16 by moving the language in the last bullet, beginning on line 20, to the end of the first paragraph on line 4, and by deleting the language on line 5 and inserting the statement: OTHER STUDENTS MAY ENROLL IN 500-LEVEL COURSES WITH THE FOLLOWING RESTRICTIONS:.

  - 6.5 It was m/s/p (Cleman) to table further discussion of document 06-16.
