- 7.3 It was m/s/ (Classen) to amend lines 432-433 of document 09-3 by deleting the words or promotion to a higher rank.
- 7.4 Debate ensued.
- 7.5 The Classen motion was withdrawn.
- 7.6 It was m/s/p (Classen) to amend line 432 of document 09-3 by deleting the word or and inserting the word AND.
- 7.7 Debate ensued.
- 7.8 It was m/s/p (Cleman) to reconsider the Classen motion.
- 7.9 It was m/s/ (Baaske) to amend line 471 of document 09-3 by inserting the words EMPLOYED BY CSULA AND IN THEIR CURRENT RANK FOR AT LEAST TWO YEARS after the words "faculty member."
- 7.10 Debate ensued and it was agreed by consensus to include the words WHO HAS BEEN in the Baaske motion before the word "employed."
- 7.11 Senator Fabris suggested as a friendly amendment that the Baaske motion be amended by inserting the words ONLY IF EMPLOYED BY CSULA AND IN THEIR CURRENT RANK FOR AT LEAST TWO YEARS AND on line 472 after the word "action."
- 7.12 Debate ensued and the Baaske motion was withdrawn.
- 7.13 It was m/s/f (Baaske) to amend document 09-3 by inserting the following new sentence at the end of line 475: A FACULTY MEMBER APPLYING FOR EARLY PROMOTION MUST BE EMPLOYED BY CSULA AND IN THEIR CURRENT RANK FOR AT LEAST TWO YEARS.
- 7.14 It was m/s/f (Cleman) to amend document 09-3 by deleting the word generally on line 523 and deleting the sentence However, when a faculty member is hired with credit towards tenure, activities during the year or years for which they have received credit towards tenure shall also be considered. on lines 526-529.
- 8. It was m/s/p (Bowman) to adjourn at 3:09 p.m. and to continue document 09-3 on the agenda as a second-reading item.
