 - 1.1.1 On April 19th, President Rosser returned unsigned the Senate's proposed modifications to the Policies and Criteria Governing Retention, Tenure and Promotion and the policy on Range Elevation Criteria for Temporary Faculty and the proposed policy on Peer Observation of Instruction.
