1. The Chair's announcements:

1.1 At the Executive Committee meeting on November 26, 2014, it was m/s/p to approve by Executive Action the modification of the following policy from the Faculty Handbook:

Probation and Disqualification Policy for Graduate and Postbaccalaureate Students

Rationale: Deleted 16 and inserted 12 before units in line 11 and deleted the word quarter/quarters and inserted SEMESTER/SEMESTERS wherever it appeared in the policy. Previously postbaccalaureate students had 16 units or 2 quarters, whichever came later, to raise their grade point average before being disqualified. However, there is not a straight mathematical conversion so the Executive Committee made an editorial change the policy to 12 units or 2 semesters, whichever comes later.

1.2 The committee also approved by Executive Action the deletion of the following policies from the Faculty Handbook:

Integrity of Scholarship and Grades

Rationale: The content of this policy has been subsumed in the Policy on Academic Honesty.

Policy on Training and Support for Student Computing

Rationale: This policy is 20 years old and student computing is well integrated into the curriculum making this policy no longer necessary.

1.3 The committee also approved by Executive Action the deletion of the following extraneous language/placeholders referencing various appendices from the Faculty Handbook. The referenced statements/procedures/regulations are not being deleted and are still intact in the appendices. The deleted text is extraneous as these appendices are referenced in the table of contents.

Statement of Student Rights and Responsibilities - Rationale: Reference to Appendix F.

Student Grievance Procedures - Rationale: Reference to Appendix G. Student Disciplinary Procedures - Rationale: Reference to Appendix H. Communications Code - Rationale: Reference to Appendix I.
