1.1.7 Please come prepared to nominate faculty for two ad hoc advisory committees – one for the Dean of the College of Health and Human Services and one for the Vice Provost, Diversity and Engaged Learning. For the Dean of HHS, one tenured faculty member, not from the college concerned, is to be elected by the Academic Senate. For the Vice Provost, four tenured faculty members (no more than two from any one college) is to be elected by the Academic Senate from the university at large. It would be helpful if you obtain approval from the nominated colleague in advance. The work of these committees will commence in the Fall.

1.2 Senator Talcott announced: As you have likely heard, the results are in on CFA members voting on the ratification of the tentative agreement. 97% of members voted in favor of the agreement, and we had a 63% turnout on the vote. Thank you to all of you who participated in the struggle for fairer salaries for faculty, including being willing to go on strike, talk to your colleagues, and ultimately vote on the tentative agreement. Sunday was May day, international workers day, and it was also the date we were set to reopen on the 2016–17 contract salary article. Thanks to thousands of engaged faculty, and to our students who stood with us, that did not have to happen. On May 24 and 25th, the Board of Trustees meets, and at that time I anticipate they will also ratify the agreement.

PROPOSED POLICY MODIFICATION: PROTECTION AGAINST MISCONDUCT IN RESEARCH, FACULTY HANDBOOK, CHAPTER VI (15-19, AP 102)
First-Reading Item

- 11. 11.1 It was m/s/ (Syed) to amend lines 9-16 by deleting the language: Ten percent of the graduates in each college will receive honors: the top 1% will receive summa cum laude, the next 4% will receive magna cum laude, and the next 5% will receive cum laude. These percentages will be calculated only once for each academic year. The academic year is defined as summer, fall SEMESTER, winter, and spring quarters SEMESTER. At the beginning of each summer quarter FALL SEMESTER, grade point average requirements for graduation with honors will be set by the Registrar's office. These averages will be determined for each college by applying existing policy to students who have graduated during the past three years.* (including the footnote *Detailed method: The Registrar will look at grade point averages for every student who graduated in a particular college during the past three years. The percentage cutoffs in the current policy (i.e., 1% for summa cum laude, 4% for magna cum laude and 5% for cum laude) will be applied to this combined group to determine grade point average cutoffs for each school. and adding the language:
SUMMA CUM LAUDE: GPA EQUAL TO OR GREATER THAN 3.9
MAGNA CUM LAUDE: GPA EQUAL TO OR GREATER THAN 3.75 BUT LESS THAN 3.9
CUM LAUDE: GPA EQUAL TO OR GREATER THAN 3.500 BUT LESS THAN 3.75.
