- 1.2 Senator Peterson announced: It is with great sadness that the Department of Sociology announces the passing of Dr. Jon Snodgrass, our longtime colleague and friend who was a faculty member at Cal State LA for 43 years. Dr. Snodgrass retired this past spring and was recently honored with emeritus status. He was teaching as part of the FERP program until his passing. The Department will host a memorial in a few weeks for those who wish to honor Dr. Snodgrass and will provide details once they are available.
- 2. 2.1 Senator Prabhu raised the following concerns (on behalf of students):
- CONCERNS FROM THE FLOOR
- Summer Classes: Students, who are planning to graduate this Summer are
 concerned about whether the required courses needed for timely graduation will
 be offered this Summer, given the short span. Furthermore and more
 importantly as to when these courses will be confirmed so that they can plan
 their graduation accordingly.
- 2. Steep and differential pricing for beverages: Students complained that there was a steep price difference in the cost of hot beverages like coffee across the campus They specifically mentioned that the cost of one cup of coffee at Salazar Hall (located outside the cafeteria) was \$5 and for night classes (especially in winter) this seems to be the only place to buy coffee.
- 3. Vending machine: Students referred to the vending machine as "wicked" as on several occasions the machine accepts their money (especially the high denominations \$5; \$10) but does not give the food item. It is extremely frustrating for students, especially for evening classes, when the machine is the only source of food.
- 2.2 Senator Dumitrescu raised the following concern: Students in one of my classes expressed concern about the incoming faculty strike, fearing that, like in Latin America, from where some of them are, the university will be paralyzed indefinitely and they are going to miss the term and, therefore, jeopardize their timely graduation.
