1. 1.1 Chair's announcements:

- 1.1.1 Great news! The Senate Representation Proposal passed with slightly more than two-thirds voting in favor of the proposal. The total votes were 191: 129 votes in favor and 62 votes opposed. A special thank you to President Covino who approved the proposal on March 22.
- 1.1.2 The call for nominations and elections for lecturers and staff have gone out to the colleges and the VPAF Office. The Academic Senate, during its meeting on March 13th, randomly assigned the following staggered terms of membership for 7 lecturers:

- 1.1.4 CSU Advocacy! The CSU Trustees' 2018-19 support budget requested an additional \$263 million in state funding. Governor Brown's 2018-19 budget proposal released in January allocated just \$92.1 million, leaving a \$170.9 million shortfall. The proposal translates to a 1.4 percent increase to the CSU's operating budget that is half the rate of inflation and is \$61 million short of what is needed to cover mandatory cost increases.

CONCERNS FROM THE FLOOR

- 1.4 Senator Baaske announced: Senators, today is National Equal Pay Day. It is unfortunate that Americans must be reminded that all people deserve to be paid without regard to sex, gender, race, ethnicity, and other protected status. Faculty should know that faculty salaries are public record, so anyone can see how their pay compares to others of similar rank and expertise. And, the collective bargaining agreement specifies a process for faculty to seek an equity increase if their pay is not equitable. We should be thankful that we have such protections and wouldn't it be nice if everyone else did, too.
- 2.1 Chair Prabhu presented a concern raised at an Executive Committee meeting on behalf of Laura Witcomb, Faculty, Management: A major driver for shifting from quarters to semesters is that administrative costs should be lower. Tasks that previously had to be done 3 times now only have to be done twice. At the same time, resources needed for teaching are greater. Under quarters, it is easier to maintain a higher full to part-time ratio. With the shift to semesters, more sections are offered at one time, so more full time faculty are required than under quarters to maintain the same ratio. I am curious as to whether the proportion of administration costs as a proportion of total costs has declined compared to quarters. While many worthy projects have been embarked upon, I fear more hires have occurred in administration without recognizing the extent of catch-up required in faculty hiring for semesters. I would be interested in the university's overall full to part-time ratio over the past 5 years. It would also be useful to benchmark against other CSU campuses.
 - 2.2 Chair Prabhu reported that a discussion was held and the Executive Committee recommended that they share the TT density report (shared by the CO and drafted by the task force) which has the necessary data. It was recommended that it would help to have system wide data comparing TT/T faculty; lecturers; staff; MPPs. Statewide senators Baaske and Riggio will follow up with ASCSU.
- 3. Chair Prabhu presented the following response from Lynn Mahoney, Provost and VPAA, to the Intent to Raise Questions from Senator Aniol on March 13, 2018 (ASM 17-12): Dear Academic Senate:

Eligibility to apply for an institutional grant is explained in Chapter V of the Faculty Handbook: Eligibility. All regular full-time faculty, faculty in the pre-retirement reduction in time base program, emeriti faculty and faculty participating in the faculty early retirement program may apply for Institutional Grants. Usually proposals are submitted by individual faculty members, but joint proposals also are considered. On rare occasions a group of faculty members, representing either a single discipline or an interdisciplinary shared interest, may submit a collaborative proposal with supporting justification.

While we deeply value the contributions of our lecturers, they are not eligible to apply for institutional grants.

3.2 Chair Prabhu presented the following response from Lynn Mahoney, Provost and VPAA, to the Intent to Raise Questions from Senator Bettcher on March 13, 2018 (ASM 17-12): Dear Academic Senate:

Every year, the university substantially augments the meagre funds we receive from the Chancellor's Office to support faculty research and creative activities. This augmentation includes funding for additional funds for RSCA Awards and sabbaticals. Our goal is to maximize the number of research active faculty who get some kind of support annually, as well as to continue to identify sources of funding for research support. To meet the goal of offering support to more faculty, we have implemented several changes for 2018-19. To increase the number of faculty who benefit from RSCA Awards, we are going to allocate more funding for assigned time by reallocating funds formerly used for Creative Leaves. In the 2000s, RSCA funds from the CO included a category for Creative Leaves, which were intended for Assistant Professors during the probationary period and awarded much like sabbatical leaves with a requirement that faculty return to the CSU after their leave. At the end of that decade, RSCA funds were suspended, and, when programs

returned briefly in 2010-11, and, again in 2014 (after another three-year suspension of funds), Creative Leaves were not included as part of the RSCA program from the CO. There was a campus decision to continue granting Creative Leaves, although they were no longer part of the CO's program. Many of the Creative Leaves were awarded, however, to faculty who were not probationary, which was not the intent of the original program.

In consultation with the Deans, the associate vice president for Faculty Affairs, and the associate vice president of Research, I decided to redirect these funds to assigned time in order to provide support for far more faculty. Last year, we awarded six faculty Creative Leaves and thirteen faculty assigned time. We anticipate that we will instead be able to award closer to forty faculty assigned time to pursue their research and creative activities.

As a result of a very positive benefit gained for faculty through the collective bargaining process in 2014, all new probationary faculty receive four course releases awarded over their first four terms funded by our campus. And in continued support of continuing faculty, we will increase the number of sabbaticals awarded annually to eligible faculty as funding allows (with a minimum of 2-3 additional awards).

We are not funded anywhere near adequately for research, and I look forward to continuing our work as a campus community to identify opportunities to generate additional funds to support additional faculty.

"The Office for Students with Disabilities" is currently considering a name change to emphasize Abilities rather than Disabilities.
