- 1.3 Senator Bezdecny announced: Puerto Rico has been devastated by Hurricane Maria. Only 10% of the island has electricity or water, nearly all 3.5 million people are still without such basic necessities as food, water, shelter, and power. FEMA and Red Cross are making their way around the island, but even they don't know where everyone is located or where all the roads that have been blocked are, buildings that have been ripped apart, and infrastructure that was damaged.

 That's where you come in. We will be staging a Mapathon to help document what Puerto Rico looked like before the storms to aid ongoing emergency response efforts. All you need to do is show up and map. No experience is required we will provide training to everyone attending. Food and drinks will be provided. This will take place on Saturday, October 14, 9am-6pm and Friday, October 20, 10am-6pm in the King Hall Map Room, 4th floor, D wing.

Senator Acevedo raised the following concern: In the past, when a student withdrew from all of his/her classes and received "W" grades, those "W" grades did not prevent the student from retaining his/her continuing student status. Last week, I discovered that receiving a "W" no longer permits students to maintain his/her continuous enrollment status. The Registrar's Office referred me to the Faculty Handbook, which indicates that this policy has been on the books since 2015, but is just now being enforced.

First, can the Academic Senate make sure that if there is a policy or procedure that it is listed in the faculty handbook that affect students, that that policy or procedure also be written in

the catalog. Currently, the University Catalog merely stipulates that "Students maintain their continuing student status for registration purposes only by attending at least one of the two semesters immediately preceding the semester in which they plan to enroll (excluding the summer term).

Second, before the University enforces a policy or procedure, an email should go out to all faculty and staff in the Colleges informing them when this policy will be enacted and enforced.
