Senator Marmolejo raised the following concern: I find it disheartening and very contradicting for a university whom prides themselves in upward mobility and the #1 in the nation's most diverse campus, our mission statement clearly states, "that we will amplify our student's unique talents, diverse life experiences and intellect." Highlighting our "students diverse life experiences, which last time I checked, Trump's border wall is a monument of white supremacy, targeting the Mexican border for propaganda and racial oppression. Student concerns have been brought up to my attention as well as yours, President Covino regarding your lack of action to student security, student empowerment, and attention to the Young Americans for Freedom's display of "Build the Wall" in the main walkway. Your vague email left many confused as to what your message was even regarding. This is a call to action from your students, we need our administration, specifically our President not only to delegate support groups and workshops but participate in events that promote solidarity of the students. We need greater actions such as monumental statues of leading community and historical figures, and funding for high profile speakers whom will speak on the importance of community and diversity which are school values. We the students do not get paid the outstanding amount of money you do. President Covino, therefore it should not be our responsibility to continue to find solutions for you. We need better leadership, we need better advocacy from our administration, our students deserve better!

2.2 Senator Finocchiaro raised the following concern on behalf of a graduate student: Academic Senate,

This letter as an official request for the University to revisit the process for <u>the Loss</u> of <u>Matriculation Policy</u> at California State University, Los Angeles.

The policy for the **loss of Matriculation** for graduate students does not require the university to notify the student of the process for matriculation or that they will be dropped from the entire program.

The concern is the following: The process does not hold the university accountable for any notifications for this policy. Graduate programs do not have centralized advisement like Undergraduate students. Faculty advisors do change often for the graduate programs and because of those changes, the faculty advisors might not be aware of all the policies and will not inform the students that they will be dropped unless the students specifically asks that question.

The section specifically addressing process and procedures for leave of absence is hidden in the catalog. If a student does a straight search for a leave of absence, the section discussing the leave is at the very bottom of the search (5th section) under procedures and regulations. It is tricky to find and the student has to read through a lot of material to find the policy.

The verbiage of the policy is also vague, it does not cover the outcome of absence for more than one semester.

Solution: It would be ideal that some sort of communication is sent to the students after one absence notifying them that they will lose matriculation and get dropped out of the program if they do not file for an official leave of absence by the specific deadlines determine in our policies.

The statement that the University does not need to notify the student that they will be dropped because it is mentioned in the catalog is unfair to the students. Getting dropped from the program is a big change to the student's status and they would have to wait one to two years before then can reenroll. One courtesy email should alerting the student would be greatly appreciated considering the outcome and all the anxiety/ stress caused by this to the student.

Application process: I understand that some policies have to be harsh to keep the program operating effectively, However, please consider allowing the students that lost matriculation to apply sooner since most of the graduate courses run once a year. But if the university cannot do this, they should consider notifying the students in writing instead of penalizing the students for lack of knowledge or familiarity with the catalog.

Please review this policy and procedure on graduate student matriculation.
