Ake Sandler, Emeritus Professor of Political Science, who has served the Association in this office during the past year.

Members-at-Large of Executive Committee (2-year terms)

Arthur J. Misner, Emeritus Professor of Political Science, who has served by appointment on the Executive Committee during the past year.

Leonard G. Mathy, Emeritus Professor of Economics, who also served as Dean of the School of Letters and Science and as Dean of Instructional Administration during his 33 years on the University faculty.

State CFA Leader To Speak; Officers Will Be Elected

William D. Crist, President of the California Faculty Association, will be the speaker at the Annual Spring Meeting of the Cal State L. A. Emeriti Association on Thursday, April 18. He will speak on the subject, "Collective Bargaining and Academic Excellence in the CSU".

The meeting, at which officers will be elected for the coming year and reports of officers and committee chairman will be made, will be held in the Gold Room of the University Cafeteria, beginning at 1:30 p.m. It will be preceded by a luncheon in the same room at 12:30 p.m. Reservations for the luncheon (\$6.50 per person) must be made and checks (made out to the "Emeriti Association") must be received no later than April 10 by Winona Brooks, 149-B Casuda Canyon Drive, Monterey Park, CA 91754.

Dr. Crist, Professor of Economics and a member of the faculty at Cal State, Stanislaus, since 1962, has served on the board of directors of the CFA since its organization in 1974 and has been its president since 1976. The nation's largest faculty bargaining unit, CFA represents more than 19,000 faculty on the 19 campuses of the California State University system.

He also has served as state president of the California College and University Faculty Association, as a member of the CSU statewide Academic Senate, and as chair of the Academic Senate on his home campus. Nationally, he has served on the National Education Association's Higher Education Council, and currently serves on the editorial board for the NEA's journal, "Thought and Action". He also serves on Committee N (collective bargaining) of the AAUP.

President's Perspective

One of our major projects for the year has been realized; another has suffered a setback.

The California State University Association of Emeriti Professors is now a reality, after an organizing campaign of over eight months (See story on next page). What I want to add is comment on some of the exciting opportunites and challenges on the horizon for this new organization, and its urgent need for a host of members if it is to fulfill the promise it offers.

A canvass of knowledgeable officials of the leading national organizations discloses that none of them knew of another such systemwide association of retired faculty. Clearly this is a pioneering effort, in a posi-

It is the mission of CSUAEP to seek to improve the lot of every retired faculty member in the system. In particular, it will be able to address the key retirement problems that are systemwide in scope, beyond the capacity of local campuses to resolve. Already it is opening lines of communication among the scattered emeriti of CSU, facilitating the sharing of useful information about our common concerns. It will enable us to learn from each other and to act in concert on a much larger scale, and with greater effect. Among other beneficial consequences will be better record-keeping about emeriti and their historic contributions, as well as of their skills and expertise, and means of gaining access to them.

New outreach opportunities abound, especially for enlisting and lending support to worthwhile causes, both professional and personal. In prospect is liaison and cooperation at the state level with RPEA and CFA on the preservation and enhancement of retirement benefits, and the building of constructive relationships with the Statewide Academic Senate and the CSU Administration, on foundations already being laid. A case can now be made for emeriti voting representation on the CSU Senate and for a Senate committee on retirement issues.

Also possible will be the exploration of ways in which emeriti can continue to serve the University and the Administration can assist the association. The scholarly pursuits of emeriti also are likely to benefit from AEP advocacy. Even further, alliance is within reach with emeriti in other segments of higher education in California, as the emeriti movement spreads.

Ultimately, the efficiency of our new statewide Association of Emeriti Professors depends upon the support it receives from its constituency. Its membership will consist solely of dues-paying individual emeriti of CSU. I strongly urge each and every one of you to join by sending a \$5 payment of annual dues to Treasurer

State Association of Emeriti Professors Formed

The statewide California State University Association of Emeriti Professors was formed at an organization meeting which took place January 25 at CSU Headquarters in Long Beach.

Participating in the organizing session were representatives from nine CSU campuses, plus observers from two others. Addressing the representatives at their opening session were CSU Chancellor W. Ann Reynolds and members of her administrative staff, including: Dr. Herbert Carter, Vice Chancellor, Administration; Dr. William Vandament, Provost and Vice Chancellor, Academic Affairs; and Dorothy Miller, Associate Dean of Faculty Affairs, representing Caesar Naples, Vice Chancellor of Faculty and Staff Affairs.

The assembled campus representatives adopted a constitution and bylaws for the new association and then proceeded to nominate and elect its first slate of officers and directors. Sidney P. Albert, who was principally responsible for initiating the movement to form the statewide organization of CSU emeriti faculty, was elected President. Other officers elected were: Joseph Ford (Cal State, Northridge), Vice President and President-Elect; Vernon A. Ouellette (Cal State, Dominguez Hills), Secretary; and Pearl Spayde (Cal State, Sacramento), Treasurer. Chosen as Members-at-Large of the Executive Committee were Edwin R. Carr from Cal State. Fullerton, and Ambrose Nichols, Jr., from Sonoma State University. Those elected will serve until June, 1986.

The new association is believed to be the country's first independent organizaton of emeriti faculty in a multi-campus university system.

"We seek to establish emeriti faculty as fully recognized, continuing and contributing members of the academic community", Association President Albert said following the meeting. "The emetiti of The California State University system are a rich academic resource, still largely untapped. Organized, they will be in an improved position to render valuable service to their faculty colleagues, to the university, to higher education in general, and to each other."

Overall governance of the new association will be placed in the hands of selected representatives of the emeriti faculty on the 19 campuses of the CSU system. Membership in the association will be open individually

to all emeriti faculty of the system, estimated to total over 2,000. Annual dues for members are \$5, payable to the Treasurer, Pearl Spayde, 5530 Moddison Avenue, Sacramento, CA 95819.

In Memoriam

A. Leroy Bishop Dies; Served on Education Faculty for 23 Years

A. Leroy Bishop, Emeritus Professor of Education who taught Educational Administration classes at Cal State L. A. from 1950 until his retirement in 1973, died on February 3.

Dr. Bishop earned a B.S. degree from Utah State, a M.S. degree from USC, and his doctorate from Colorado State. He served as a principal, a superintendent of schools, and a member of the faculty of Brigham Young University before coming to Cal State L. A.

Marvin Laser, Former Member of University English Faculty, Dies

Marvin Laser, Professor of English and Chairman of the Division of Language Arts at Cal State L.A. between 1956 and 1965, died February 5.

Dr. Laser left Cal State L.A. in 1965 to become a member of the founding academic group at the college now known as Cal State, Dominguez Hills. He served as Dean of the School of Humanities and Fine Arts until his retirement in 1980. He continued teaching during his years as dean and on into his retirement years.

Professor of Chemistry John R. Spielman, Dies

John R. Spielman, Professor of Chemistry at Cal State L. A., died January 5.

Dr. Spielman, holder of degrees from Stanford and USC, had been a member of the University's chemistry faculty since 1961. A specialist in the field of inorganic chemistry, he served as coordinator of the Chemistry Department's freshman program.

Granted Emeritus Status

Vincent A. Giroux, Professor of Electrical and Computer Engineering, has been granted emeritus status by President James Rosser, on recommendation of the Dean of his School and the Vice President for Academic Affairs. He had served on the University faculty since 1957.
