8. Minimum Requirements for Probation and Disqualification, EPC 02-03

This item was discussed. The following action was taken:

m/s/p to refer this item to the Undergraduate Studies and Academic Advisement subcommittees for their consideration on the following:

- 1) Based on language in the new Executive Order, determine whether a student must be on probation, except under the specified circumstances, before they can be disqualified.
- 2) If the policy allows, make a recommendation as to whether students should be disqualified at the end of each term, or at the end of each academic year.
- 3) Because it appears that the new Executive Order will have a more severe impact on students than the existing policy, particularly first time freshmen, recommend whether there should be any mitigating procedures.

Please recommend a modification of existing policy to conform to the new Executive Order. EPC suggests that the two subcommittees form an ad hoc committee to best serve both committees and to avoid duplication in their recommendations in this change of policy.
