9. <u>Upper Division GE Theme Report, EPC 03-01</u>

The Committee continued the discussion on this item. The following action was taken:

M/s/p to ask that GES include in the course syllabus template; 1) the number of writing assignments, 2) how and when timely feedback will be given; and 3) describe explicit grading criteria for the writing assignment.

M/s/p to request that 1) The Office of Undergraduate Studies send out a yearly reminder of the goals and objectives of the GE courses, 2) if compensated, theme coordinators meet annually with faculty teaching theme courses to discuss the role of the theme courses, and 3) the Chairs of the departments meet with new faculty that will be teaching theme courses to discuss the criteria and goals of GE.

M/s/p to recommend compensation for the Theme Coordinators. The compensated Theme Coordinators should be responsible for collecting course syllabi and developing a handbook. The compensated Theme Coordinators should meet with faculty teaching in their theme at least once every academic year.

M/s/p to recommend that all colleges should be encouraged to support with additional resources faculty who teach GE courses with high enrollment. The University should recognize that these courses require additional responsibilities especially in regard to the writing requirement.
