## 1. Call to Order

M. Garcia, Chair, called the meeting to order.

M. Garcia read the response to the intent to raise question:

- 1. M. Leung asked, "If the GET registration system can have a later starting time?"

  You are correct, it is possible to change the time but why would we? Access to the registration system is limited to a 6a.m. to midnight time frame due to the hours required for maintenance and mandatory updates and computer report processing that must occur on a nightly basis. We want to provide students with the maximum amount of time possible to access the registration system and enroll in classes, therefore, we provide them with all the hours available. I guess the interpretation of "crack of dawn" is subjective which is why the system is available as much as possible. We want students to be able to have choices and the more hours we can provide them to access the system the more choices they have to determine when they wish to participate in that process.
- 2. M. Clark asked, "If faculty can be notified about changes in registration procedures and upcoming registration dates?"

In response to Dr. Clark's question, the answer is yes. Registration dates can be found on the GET Home Page under the Registrar's Information link. Any changes to registration procedures are always included on the GET Home Page and are generally identified as NEW Procedures. In the future the Registrar will also be sure that this information is listed on the Staff and Faculty GET Home page. In addition to these links the online *Schedule of Classes* lists the continuing student registration dates on the inside cover page as well as in the Calendar, which is generally the first page of the *Schedule of Classes*.

## **NURS 218 Information Literacy for Nurses (1)**

Prerequisites: NURS 100, NURS 105

Introduction to nursing information literacy and information needs relevant to nursing domains. Introduction to the process of efficiently searching, organizing, managing and evaluating evidence-based medical information in multiple formats.

## **NURS 486 Transition to Nursing Professional Practice (2)**

Corequisite: NURS 487. Capstone course that integrates clinical decision making, critical thinking skills and theoretical knowledge for the professional transition into nursing practice. Focuses on integration, reflection and preparation for the professional role. Graded CR/NC.

#### NURS 564A Advanced Concepts in Health Care Leadership and Management I (4)

Prerequisites: MGMT 500, MGMT 578. Corequisites: NURS 595 (Advanced Field Study I). An overview of theories and concepts necessary for effective health care supervision and management with emphasis on patient/client safety within and outside of the hospital. All sections use technologically medicated instruction.

## NURS 564B Advanced Concepts in Health Care Leadership and Management II (4)

Prerequisites: NURS 564A and NURS 595 (Advanced Field Study I). Corequisites: NURS 595 (Advanced Field Study II). Principles of human resource management, economics, quality outcome measurement, management and patient safety are applied to case-based analysis at the unit-level of hospital and health care organizations. All sections use technologically medicated instruction.

## NURS 542D Family, Community and Agency Interventions in Psychiatric Nursing (2)

Prerequisites: NURS 542A and NURS 542B. Advanced psychiatric nursing evidenced-based interventions with clients in psychiatric units, general hospitals, outpatient clinics or practices, and community agencies resources that are required to promote healthy change.
