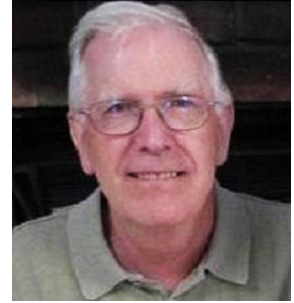

**Courses taught:** Period courses in American Literature, primarily from beginnings to 1914; Nineteenth and Twentieth Century American Novel; Graduate and Undergraduate Seminars in American Literary Realism, American Gothic Literature, The Tragic Mulatto Motif in American Literature, American Literary Regionalism, The City in American Novels, Hawthorne and James, Henry James, Edgar Allan Poe, Early American Novel, and Nature in American Literature; Introduction to Literature; English Composition at all levels.

### **Description of Scholarly/Creative Activity:**

- My primary interest was in late nineteenth-century American literature, literary realism in particular. My most significant work was on George Washington Cable, a New Orleans local color writer, contemporary and lecture partner of Mark Twain, and one of the few Southern

writers to challenge the treatment of the freedman after the Civil War and Reconstruction. I have also published articles on such writers as Charles Brockden Brown, Edgar Allan Poe, William Faulkner, Stephen Crane, and a Pacific Northwest regionalist, H.L. Davis. This last – Pacific Northwest literature – is closest to my current scholarly interests.
