#### Installment Payment Plan (IPP) - 3 Payments

Installment Payment Plan enrollment fee is \$33.00\*. The first installment is due prior to registration, the second installment is due 30 days from the issued agreement date and the 3<sup>rd</sup> installment is due 60 days from the issued agreement date. Available through July 1<sup>st</sup>, 2019.

#### Management Payment Plan (MPP) - 4 Payments

The Management Payment Plan enrollment fee is \$35.00\*\*. The first payment for fall 2019 term is due June 1<sup>st</sup> 2019. If your enrollment appointment is earlier than June 1<sup>st</sup>, then the first payment is required to register for classes. The last day to use this plan for fall 2019 is July 1<sup>st</sup> 2019, however both the June and July payments must be made to enroll at that time.
