6. Curriculum Review

MS Accountancy – MOD

- The Department of Accounting had a time-certain presentation to discuss the proposal of adding a 4+1 MSA program to their department. The committee shared the following feedback on the proposal with the department:
 - The 4+1 Track should be treated as an option, with its own admissions criteria, not a separate degree program.
 - Admission requirements for both programs (MSA and 4+1) should be revised to be consistent in terms of requirements for GPA and GMAT.
- The committee reminded the department to consider issues related to financial aid for students in the 4+1 track (i.e., Pell-eligibility for students moving from undergraduate to graduate status) and issues related to how students will receive the undergraduate degree if they meet the undergraduate requirements in the 4+1 track but don't complete the graduate requirements.
- A. Avramchuck motioned to approve the proposal pending edits and a second review via email by the GSS. The motion was seconded by K. Bezdecny and was approved by the GSS.

MA Special Education – MOD

- The GSS reviewed the MOD for the Special Education MA program for EO 1071.
- 18 of the 24 possible specialization program plans would be in compliance with EO 1071 (8 program specializations X 3 culminating experience options). If students elect to complete a thesis (4 units) or project (4 units) in the Moderate Severe Disabilities, Physical Health and Significant Support Needs, or the Visual Impairment and Blindness Orientation and Mobility options, those options would be out of compliance with EO 1071.

• Clarity is needed in defining a "core directive elective".
