#### 8.1. Executive Committee Liaison Report

R. DeChaine provided his report in electronic format: At the last meeting of the Executive Committee, (4/1/15), Rennie Schoepflin, Chair of the Q2S Steering Committee, presented an update on semester conversion activities. Here are some highlights:

- o Individual Advisement Plan (IAP) advising will begin campus-wide on May 4<sup>th</sup>.
- 6,000 students with more than 132 units of coursework completed have been targeted for high priority advisement.
- o IAP testing and training is happening now.
- O A new PeopleSoft program called "Course Planner" will be used for advisement. It provides students with a personalized roadmap (by term) to graduation.

As a follow-up to an internal audit review, the Statement of Student Rights and Responsibilities has been revised to reflect Executive order 1068, *Student Activities*. The Executive Committee has referred this to SPC for review, to ensure that the language in the Statement is consistent with the Executive Order. We should see this on our agenda very soon.

 In particular, in the Statement we will need to examine the policy on recognition of honors societies at the Honors Convocation and Commencement ceremonies; apparently there is a question about whether honors societies can be legitimately recognized at these events.
