Subject:	Proposed Policy Deletion for Chapter III of the <i>Faculty Handbook</i> FPC 18-8: Academic Administrative Positions Requiring Formal Consultation

Faculty Policy Committee reviewed FPC 18-8: Academic Administrative Positions Requiring Formal Consultation at its meeting on March 18, 2019. After consulting the policy on Ad Hoc Advisory Committees for the Appointment of Administrators: Formal and Informal Consultation, which FPC recently recommended modification, FPC voted to recommend deletion of FPC 18-8: Academic Administrative Positions Requiring Formal Consultation, since the policy on Ad Hoc Advisory Committees for the Appointment of Administrators: Formal and Informal Consultation specifically addresses 1) the requirement for formal consultation when hiring administrators and 2) specifies the positions that require formal consultation and the membership of the ad hoc committees for those positions.

Language from the policy on Ad Hoc Advisory Committees for the Appointment of Administrators: Formal and Informal Consultation:

"When an administrative vacancy requiring formal consultation is announced by the President, an ad hoc advisory committee will be established."

Administrative positions requiring formal consultation:

- Central administrative positions, including but not limited to, Provost/Vice President for Academic Affairs, Associate Vice President for Academic Affairs, Associate Vice President for Research, Vice Provost for Enrollment Services, Vice Provost for Planning and Budget, Vice Provost for Diversity and Engaged Learning, Vice President for Student Life, Dean of Undergraduate Studies, Dean of Graduate Studies, Director of Honors College, Dean of College of Professional and Global Education or new positions of comparable rank.
- Vice President for Student Life
- Dean of Students
- College/Library Deans
- College/Library Associate Deans
- Dean of Students
