## 2 CHARGE OF COUNCIL

- 3 THE ENROLLMENT MANAGEMENT COUNCIL IS A FACULTY AND
- 4 ADMINISTRATIVE COUNCIL RESPONSIBLE FOR ADVISING THE PRESIDENT ON
- 5 ALL ASPECTS OF ENROLLMENT MANAGEMENT.
- 6 THE COUNCIL IS TO PARTICIPATE FULLY IN THE DEVELOPMENT OF POLICY
- 7 RECOMMENDATIONS, STANDARDS, AND CRITERIA RELATIVE TO ALL FACETS OF
- 8 ENROLLMENT MANAGEMENT. THE COUNCIL WILL CONSIDER ISSUES INCLUDING
- 9 BUT NOT LIMITED TO ADMISSIONS CRITERIA, THE SIZE OF THE STUDENT
- 10 POPULATION AND RATE OF ENROLLMENT GROWTH, STUDENT DEGREE
- 11 COMPLETION, THE RECRUITMENT AND RETENTION OF STUDENTS.
- 12 THE COUNCIL IS ALSO CHARGED WITH THE RESPONSIBILITY FOR ENSURING
- 13 COMPREHENSIVE AND INCLUSIVE CONSULTATION ON ENROLLMENT MATTERS
- 14 WITHIN THE UNIVERSITY COMMUNITY AND WITH OUR EXTERNAL
- 15 CONSTITUENCIES.
- 16 THE COUNCIL SHALL SUBMIT AN ANNUAL REPORT ON ITS ACTIVITIES TO THE
- 17 ACADEMIC SENATE EACH SPRING.

## 18 **MEMBERSHIP**

- 24 TWO DEPARTMENT CHAIRS TO BE ELECTED BY THE ACADEMIC SENATE
- 25 ONE SENATE EXECUTIVE COUNCIL LIAISON, TO BE ELECTED BY THE ACADEMIC
- 26 SENATE EXECUTIVE COMMITTEE
- 27 ONE UNDERGRADUATE STUDENT SENATOR TO BE ELECTED BY THE ASSOCIATED
- 28 STUENTS INC.
- 29 ONE REPRESENTATIVE FROM STUDENT LIFE APPOINTED BY THE VICE PRESIDENT
- 30 FOR STUDENT LIFE
- 31 ONE COLLEGE DEAN, APPOINTED BY THE CAL STATE LA PRESIDENT

- 32 ONE LAUSD OR HIGH SCHOOL REPRESENTATIVE APPOINTED BY THE CAL STATE
- 33 LA PRESIDENT
- 34 TWO REPRESENTATIVES FROM LOCAL COMMUNITY COLLEGES IN THE CAL STATE
- 35 LA SERVICE AREA APPOINTED BY THE CAL STATE LA PRESIDENT
- 36 EX OFFICIO MEMBERS
- ACADEMIC SENATE CHAIR (OR DESIGNEE)
