Cash and check payments can be made in person at the Cashier's Office, Administration Building, Room 128. Check payments must be made payable to Cal State L.A. Please write your CIN on your check payment. Your full payment will allow you to register on the same day, if it is your scheduled appointment date on GET. Checks deposited in the Cashier's depository drop box or mailed may take three business days to process before you can register for classes. For details, please see "Fees".
