QUESTIONS FROM THE

Why did the university feel it was necessary to issue an announcement from the Acting Provost advising that they would be docking faculty a day of pay for participating in strike activities and directing faculty to report to a supervisor if they intended to participate on the strike? It seems out of alignment with all of the other messages about the importance of collaboration and how we all work together for the benefit of our students and this institution.

There was no response from the floor.

3. Senator Joseph announced her intent to raise the following question: What can the Senate and Administration do to help all voices be heard on our campus? At the last Senate, several professors left in tears, felt silenced, and questioned the reason to break into a Senate of the Whole without giving all Senators the chance to prepare. Where are we working on sustainable actions to help the campus realize that many professors, students, and administrators are feeling isolated, scared, and abondoned.
