# ELECTION OF EMERITI ASSOCIATION OFFICERS AND ANNUAL MEETING

The Nominations Committee, appointed by Association President Kathy Reilly, will develop a slate of candidates for several open positions on the Executive Committee for 2023 – 2024. The open positions are Programs Director, Treasurer, Senate Representative, 3 Members-at-Large positions, and a delegate to the CSU Emeriti Retired Faculty and Staff Association.

In the coming weeks, the committee will send out a call for nominations for these positions and expects to finalize the slate of candidates soon after May 15, after which the election ballot will be distributed by email.

The Executive Committee has also begun to prepare for the Association's Annual Meeting scheduled for June 8. The program for the Annual Meeting will include a report by the Association president on the state of the Association as well as reports by officers and chairs of the various committees. If election results are known by that date, the new officers will be presented at the meeting.

The Annual Meeting will be a hybrid event (Zoom plus in-person) and held on the Cal State LA campus. All members will be invited, and details are forthcoming and will be announced via email.

In my last message I looked forward to moving into my first year as president. We have awarded up to \$2,000 each to 31 outstanding scholarship and fellowship recipients, and we have begun a fundraising plan to augment our various endowments. We have


appreciated President William A. Covino's support and look forward to continued good will and cooperation as we transition to the naming of Cal State LA's new president. This includes providing us with the use of an Eighth Floor conference room in the renovated Student Services Building, where we can hold hybrid (both in-person and Zoom) meetings. We have approved some changes to our By-Laws to clarify and align them with text in our Constitution. We enjoyed holding our first in-person Executive Committee meeting in December and combined it with a potluck. Finally, we marked the 45th anniversary of the founding of the Emeriti Association with a presentation at the University Academic Senate.

Our goals over the next few months will continue to be guided by the purposes of the Association. We plan to revise the Emeriti Association website, which has been dormant over the past two years since the passing of our beloved former web manager Dimitri Margaziotis. The revised website will incorporate the new university standards and ease of access. We have begun a project, with the help of the University Library's Special Collections and Archives personnel, of developing a master list of all faculty since the university's creation 75 years ago. We have set a goal of providing more opportunities for newly appointed emeritus faculty and members of our Association to become involved in our programs and activities and to enjoy the benefits of membership. We have also begun to explore further the connection between the Cal State LA Emeriti Association and CSU-ERFSA, the systemwide organization for retired faculty and staff. Also, we will continue to participate in the selection of scholarship and fellowship recipients by reading and evaluating their applications for next year's awards. Finally, we anticipate generating even more ideas for our Association's programs and activities from those who participate in our upcoming retreat at the Huntington Library on March 30!

I remind everyone that members may attend the retreat for free, while non-member attendees will be asked to pay a registration fee of \$30, which will include a wonderful lunch and parking, and which will credit them with membership in the Association through December 2023.

Technology Professor Given the Wang Family Faculty Excellence Award

David Blekhman, professor of technology at Cal State LA, received the California State University's (CSU) Wang Family Excellence Award for Outstanding Faculty Scholarship. Blekhman is the first Cal State LA professor in 19 years to receive this prestigious award, and he is one of only four faculty and one staff member in the 23 CSU campuses to be selected this year. The award honors faculty and staff for unwavering commitment to student achievement and advancing the system's mission through excellence in teaching, scholarship and service. The Wang award includes \$20,000 provided through a gift from CSU Trustee Emeritus Stanley T. Wang and administered through the CSU Foundation. Blekhman and the other honorees were recognized on January 24 at the Office of the Chancellor in Long Beach. Cal State LA President William A. Covino praised Blekhman for displaying outstanding leadership in the field of alternative energy and a deep commitment to introducing innovative technologies into the curriculum.



#### <u>Cal State LA Community Remembered the Monterey Park Shooting</u> <u>Victims</u>

A memorial and candlelight vigil for the victims of the massacre of 11 people at a dance studio in Monterey Park was held on the Cal State LA campus on January 24. President William A. Covino said, "We send our deepest condolences to the loved ones of the victims, to the AAPI community, and to any of you who may have suffered the loss of a loved one." In the days following the shooting, the university provided resources for students, faculty, and staff, including grief counseling and a community circle, in addition to the vigil.



## <u>Seven Cal State LA Students Named as Sally Casanova Pre-Doctoral</u> <u>Scholars for 2022 – 2023</u>

A group of seven Cal State LA students was selected for the 2022-23 Sally Casanova pre-doctoral scholar awards, which are granted each year to support the doctoral aspirations of students across the 23-campus CSU system. Each scholar receives a \$3,000 award to help fund graduate exams, fees for professional conferences and other costs related to graduate school. The late Sally Casanova was the wife of Cal State LA Professor Emeritus Joseph Casanova. Also, former Emeriti Association president Jose Galvan is a member of the Advisory Committee for the pre-doctoral scholar program and participated in the students' selection.

# THIRD ANNUAL ONLINE RECOGNITION EVENT HONORED THIS YEAR'S SCHOLARSHIP/FELLOWSHIP RECIPIENTS

Due to the campus' ongoing restrictions in response to the pandemic, the Cal State LA Emeriti Association, for the third year, held its annual recognition of scholarship and fellowship recipients online on November 29, 2022. For the 2022-23 academic year, the Association awarded 20 fellowships from the Emeriti Fellowship Fund and 11 Named Endowed scholarships and fellowships.

The Emeriti Fellowship Fund is an endowment supported by donations from members of the Association. Awards from this endowment are exclusively for graduate students from any discipline. Three of these awards are designated to honor the following individuals: Sidney Albert, considered the founder of the Association, Carol Smallenburg, one of the founders of our fellowship program, and former campus president James M. Rosser, who was a strong supporter of the Association.

The Association also administers the awarding of scholarships and fellowships from endowments established by Association members or their families and which bear either the donor's name or that of someone they wish to memorialize. These are identified as Named Endowments, and according to the donors' wishes may be awarded to either undergraduate or graduate students.

The 20 Emeriti Fund Fellowship recipients and 11 Named Endowed Scholarship/Fellowship recipients for 2022-23 represented 5 of the university's colleges and 17 departments. Of these, 15 students participated by introducing themselves at the November 29 event, and another 3 submitted statements that were read for them.

Association President Kathy Reilly opened the event and then introduced Jose Gomez, Provost and Vice President for Academic Affairs, who delivered the campus welcome. Dr. Gomez noted that the Cal State LA Emeriti Association was the first emeriti organization in the CSU, that Association members are some of the most loyal donors to the University, and that the Association awards more scholarships and fellowships than any other Emeriti Association in the CSU.

The honored scholarship and fellowship recipients were introduced by Alfredo Gonzalez, chair of the Fellowship Committee, and by Deborah Schaeffer and Dorothy Keane, both members of the committee.

The presentations given by the honored students were moving, inspiring, touching and powerful. Their remarks provide strong evidence of the quality of students that attend Cal State LA, the immense hardships many of them face and overcome, as well as their intellectual curiosity, abilities and pursuits. Several spoke of their goals to pursue doctorates, teach at a university, inspire students like themselves and others, and bring about a more just and humane world.

The students expressed their appreciation for the financial support provided, indicating that it helped make their material conditions a little easier. In addition, most of them remarked on the confidence boost the awards provided, validating their hard work, academic achievements, and accomplishments.

# 45 YEARS LATER, THE EMERITI ASSOCIATION STANDS PROUD

Most members of the Cal State LA Emeriti Association should be aware that our organization became the first of its kind in the CSU when it was created in 1978, and it was instrumental in developing retired faculty protections and privileges in the statewide system. But many more recent members may not be aware of the struggle to achieve those goals and benefits, unless – as I highly recommend – they have read Sidney Albert's detailed account available on the Association website. (That account can be accessed on the <u>Emeriti history page</u>.)

From my own most recent reading of that account, two features of the struggle and the Association's achievements seem worth noting.

The first is the resistance to the aims of the emeriti in creating an association, which were essentially to be able to continue to do research and participate in university life after retirement. The resistance at both the LA campus and statewide was largely economic, the concern that funding emeriti research would compete with funding for regular faculty research and other needs on campus. Since emeriti were no longer employees, they didn't qualify for traditional forms of support from the university.

Also, the role of continuing participation in campus life through membership in the Academic Senate was resisted by some in the Senate on the grounds that emeriti were no longer attuned to current campus issues and so should not have a vote in how these matters were considered.

Proposals were offered in the Senate to accept one non-voting emeritus faculty member, but the newly created Association held fast, and the single emeritus representative, with voting privileges, was approved by a slim two-vote margin.

In sum, the Albert account suggests that, in the eyes of the administration of the time, admitting the Emeriti Association into the campus family was something of a begrudging favor to honored retirees rather than a particular benefit to the university.

The second notable feature of the account, for me at least, is the irony of the long-term benefit that the Emeriti Association has bestowed on Cal State LA, rather than the other way around.

The focus of the Association in recent years has increasingly shifted from gaining and maintaining status for emeriti to providing service in various forms to the university and to its students. The primary example of this is the awarding of student fellowships and scholarships. Thanks to the generosity of donors, emeriti and others, the Cal State LA Emeriti Association is now the largest awarder of fellowships and scholarships in the entire CSU system.

So, what was once regarded as something of a threat to the university by potentially diluting support to current faculty, has become instead a significant benefit to its students and thereby to the reputation of the University and its mission as the leader of "upward mobility."

We can be proud.

# SEARCH FOR NEXT PRESIDENT OF CAL STATE LA IN PROGRESS


As *The Emeritimes* went to press, the search process for selecting the successor to Cal State LA President William A. Covino was still underway. President Covino previously announced his retirement effective June 30, 2023. The announcement of the new president is expected sometime prior to the start of their term on July 1, 2023.

Part of the initial process for selecting the next president included a hybrid Open Forum held on the campus in early November 2022. The forum was intended to provide campus constituents an opportunity to share with the Search Committee what they feel are the qualities and experiences that are important for the new president to have. This was the only public event of the search that is open to the public. # LIFELONG LEARNING PROGRAM INVITES EMERITI FACULTY SPEAKERS

One of the important programs of the Cal State LA Emeriti Association, the Lifelong Learning Program, schedules emeriti faculty from a variety of disciplines to speak at senior residences and community centers in Los Angeles and the San Gabriel Valley. Directed by emeritus professor Peter Brier, the program has been recruiting Cal State LA emeritus professors to participate in the program for more than 15 years.

Participating speakers receive a \$100 honorarium for delivering a 45-minute presentation. # **PROFESSIONAL NOTES**

This column includes descriptions of the research, professional activities, and publications of emeritus faculty. Your contributions to future columns are welcomed and encouraged. **Gerald Beer**, Emeritus Professor of Mathematics, has a monograph, *Bornologies and Lipschitz Analysis*, that will be published in April 2023 by CRC Press, part of Taylor and Francis publishers. Also, he recently co-authored two papers, "Stability of Lipschitz-type functions under pointwise product and reciprocation," with M. Isabel Garrido and Luis Carlos Garcia-Lirola, in 2020 in the journal *Revista de la Real Academia de Ciencias Exactas*, *Fisicas Y Naturales*, and "Embeddings of topological posets in hyperspaces," with Efe Ok, in 2021 in the journal *arXiv*.

**Stanley Burstein**, Emeritus Professor of History, published a book, *The World from 1000 BCE to 300 CE*, New Oxford World History, 2017.

**Roberto Cantu**, Emeritus Professor of Chicano Studies, has published a new book, Jose Antonio Villarreal and Pocho: A Mexican American Novel and Its Tragic Plot (Cambridge Scholars Publishing, 2020). The book is a semi-autobiographical novel about Richard Rubio, a Mexican American youth raised in central California where people self-identified according to race, ethnicity, or religious affiliation. Dr. Cantu holds a joint appointment in the College of Natural & Social Sciences and Arts and Letters. His publications range from book reviews, articles and books on Chicano and Mexican writers as well as Mesoamerican civilization. He has also organized conferences with colleagues at Cal State LA highlighting the contributions of many contributors to Mexican American literature, most recently Rudolfo Anaya.

**Daniel Crecelius**, Emeritus Professor of History, had his tribute to the famous Georgian historian and diplomat Gocha Japaridze, with whom he published several articles on Georgian mamluks in 18th century Egypt, included in the memorial to Dr. Japaridze's career in *Historical Collections*, no. 8, 2021. In addition, he was inducted into the Class of 2021 Hall of Honor at Lutheran High School North, his alma mater, in recognition of his distinguished career. The induction dinner was held at the Norwood Hills Country Club, St. Louis, MO, on Oct. 2, 2021.

**Domnita Dumitrescu**, Emerita Professor of Modern Languages and Literatures, coauthored the following articles: "Diversidad lingüística y obras lexicográficas," in *La diversidad del español y su enseñanza*, ed. by N.H. Muñoz, J. Muñoz-Basols and C.S. Montes, Routledge, 2021, and "A manera de prólogo," in *El inglés y el español en contacto en los Estados Unidos Reflexiones acerca de los retos, dilemas y complejidad de la situación sociolingüística estadounidense*, ed. by S. Betti and R. Enghels, 2020. She also authored a book review, "Exploring discourse practices in Romanian," ed. by A. Vasilescu, M. Constantinescu, G. Stoica and J.R. White, in *Language and Dialogue*, vol. 1, no. 2, 2021.

**Steve LaDochy**, Emeritus Professor of Geosciences & Environment, coauthored a paper, with student Antonio Santana and Todd Hall of the National Weather Service, entitled "The changing climate of Los Angeles: Highlights from the last three decades," which was presented at the Association of Pacific Coast Geographers Annual Meeting, Oct. 15, 2021. The paper received the President's Outstanding Undergraduate Paper during the meeting.

Lauri Scheyer, Emerita Professor of English, edited the book, *Theatres of War: Contemporary Perspectives*, Bloomsbury, Oct. 2021. This collection discusses more than 30 international plays and case studies from different time periods, which are all set in a backdrop of war. *Continued on page 11.*

**Sandra B. Sharp**, Emerita Professor of Biological Sciences, was appointed to serve on the Huntington Medical Research Institutes (HMRI) Board of Directors, 2021. HMRI is a nonprofit, independent biomedical research organization dedicated to finding diagnostic tools and treatments for serious diseases that affect millions of people each year.

**David Weiss**, Emeritus Professor of Psychology, has published an article with Dr. James Shanteau of Kansas State University: Weiss, D. J., & Shanteau, J. (2021). "The futility of decision making research." *Studies in History and Philosophy of Science*, Part A, 90, pp. 10–14. In this article, they lament the fact that after 50 years of doing research they feel that their field of judgment and decision making (JDM) "has had little or no impact due to the failure of psychological models that use methodologies that emphasize testing models rather than looking for differences in behavior." They feel their methods of research have not stood the test of time and urge their successors to "study real decisions. Manipulate something real and see how decisions change. That's what audiences attend to; what people expect to see."

# **MEMBERSHIP DUES AND RENEWAL NOTICE**

The Emeriti Association has just announced two important changes pertaining to our membership dues and renewal terms.

First, the Emeriti Association recently adopted a calendar-year membership term starting with January 1, 2024. This replaces the fiscal year calendar (July 1 – June 30) that was previously in place. So, if you join at any point before 2024, your next renewal will not be due until January 1, 2024!

Second, the Association recently adopted a modest increase in dues to defray increased expenses for our programs and operations. Effective January 1, 2024 the annual membership dues will be \$50 (up from \$30) and the life membership will be \$300 (up from \$250). Note that the last dues increase occurred in 2016.

# Researcher In Adult Development and Textbook Author

## A Second Emeritus Designation after Leaving Cal State LA

Greetings from Lake Mary, FL, where I now reside after my second retirement in 2021, this time from the University of Central Florida (UCF), Burnett School of Biomedical Sciences, College of Medicine, in Orlando, FL.

I had the honor and privilege of serving our Cal State LA institution, Department of Biology and Microbiology, from 1963 to 2004, first as a tenured Associate Professor (coming from Loyola University of Chicago, Departments of Biology and Medical Physiology) and finally as Professor. In 2004, I moved to UCF in Orlando, FL, as a tenured Full Professor and Director of the Pre-Health Professions Advisement Office, where I ended my career in 2021 in the midst of the global COVID pandemic.

During my tenure at Cal State LA, I directed the Medical Careers Advisement Office, where I guided scores of pre-health professional students—both represented and underrepresented—who aspired to careers, including MD, DO, Dentistry, Chiropractic, and various others. I was privileged to secure several grants from the US Department of Health and Human Services in the years 1982 – 2004, including the first-ever Model Hispanic Health Careers Opportunity Program, which provided \$5 million to support our efforts, with Dr. Costello Brown as coprincipal investigator.

So much more to narrate, but I just wanted to let my beloved Cal State LA Emeriti Association colleagues know that I had to try to replicate my efforts for deserving pre-health professional students across our country. I am very proud of the UCF Burnett School of Biomedical Sciences, College of Medicine, which conferred on me a second emeritus designation in 2021.

Professor of Communication Studies, 1972 – 2000



#### **Christine C. Givner** Professor of Special Education, 1993 – 2004

Christine C. Givner passed away at the age of 69 on June 6, 2022, at the Buffalo General Hospital in Fredonia, NY, after a short bout with cancer. She was born on February 9, 1953 to Norman Cassatt and Betty Flasher in Warren, PA.

Givner attended Allegheny College and eventually earned a PhD in education at the University of Pittburgh. She began her career at Johns Hopkins University in Baltimore, MD, where she conducted research for three years before joining Trinity College in Burlington, VT as a professor of special education. Five years later, in 1993, she joined the faculty in the Division of Special Education and Counseling at Cal State LA.



While at Cal State LA, Givner made significant contributions to the Mild/Moderate Credential and the masters degree programs, and eventually she became chair of the Division.

She returned to the East Coast in 2004 to become the founding dean of the College of Education at State University of New York at Fredonia, where she worked tirelessly for 16 years. She retired as dean emeritus in 2020, having mentored countless students, professors, and academic administrators.

Givner has made an indelible impact on the field of special education and higher education and will be remembered for her insightful publications over the years.

She is survived by her husband of 50 years, James Givner, and a loving son, Jelani, daughter-in-law Rachel Ross, and their beautiful grandson, Paxton Ross-Givner. A virtual Celebration of Life was held last summer that was attended by a number of her Cal State LA colleagues.

Professor of Education, 1992 – 2023

Professor John Eichinger, beloved professor of science education in the Division of Curriculum and Instruction, College of Education, passed away on January 3, 2023 at the age of 70. Professor Eichinger was hired at Cal State LA in 1992 and was professionally active in the field of science teacher training. He published numerous scholarly works in this area and was a frequent presenter at conferences and workshops. #### Keith Mew

Professor of Technology, 1997 - 2018 Director of the Aviation Administration Program

The following obituary was prepared by Professor Mew's son.

Professor Keith Mew, former Chair of the Technology Department and Director of the Aviation Administration Program at Cal State LA, died on October 2, 2022 at the age of 69. Professor Mew was active in the field of Aviation Administration, having worked on various computer systems projects for Chicago's O'Hare Airport prior to coming to Cal State LA. Locally, he served on a number of advisory boards, including those of the aviation programs at Glendale College, Cypress College, Mount San Antonio College, and Orange College. He participated in numerous committees at the department, college and university levels, and in 2005 was honored as the Outstanding Professor of the Year by the Department of Technology.

Dr. Mew was born on December 14, 1952 in Southampton, England, where he grew up with his three younger sisters. He went to university in London and then obtained his PhD in Urban Planning at the University of Warsaw in Poland prior to moving to Chicago. After a short stint at Indiana University, he moved cross-country to sunny SoCal and found a home in Cal State LA until he retired in 2018.

In his free time, he loved reading biographies, was an avid classic rock fan, and enjoyed running along the beach near his Long Beach home. He was also a lifelong and devoted fan of his beloved hometown Saints, Southampton's soccer team in the Premier League.

# Did you know: MyCalStateLA accounts

As an emeritus faculty member, you retain your CalStateLA username and password, which provides access to your campus email account. In addition, you continue to have online access to the University Library's databases and its full-text journal collection. If you have any difficulty retrieving your username and/or password, either contact your college IT staff person or call the Help Desk at 323-343-6170 for assistance.

When you receive an email notice that your password will expire by a certain date, you will need to follow the steps in the first two bullets below before the expiration date. Otherwise, your account will be locked out and you will need to follow the instructions in the third bullet below.

To change your password:

- 1. Go to the **MyCalStateLA ID** website (<u>id.calstatela.edu</u>) and click **Change Password**. If prompted, log in with your current Cal State LA email address and password.
- 2. On the **Change Password page**, enter your old password, new password and confirm your new password by entering it again into the corresponding field, and then click the **Submit** button.
- 3. Passwords on locked accounts cannot be changed online. In case of account lockout, please contact the ITS Help Desk at 323-343-6170 for assistance.
