 - ITS: "Information Technology Services (ITS), in coordination with the Chancellor's Office, is working to upgrade the network infrastructure in each campus building from January through April. Computers and other devices should automatically reconnect upon completion of each section but may require a reboot."

It is EPC's opinion that while well-meaning, this proposal would be disruptive and confusing to students, and would generally create more problems than it fixes.
