INDICATE THE AREA OF THE GENERAL EDUCATION PROGRAM  
THAT THE COURSE FULFILLS.
- 7.3 Senator Kehm suggested a friendly amendment to add: AREAS, BLOCKS,  
MULTIPLE SUBJECT GRID, AND BLENDED GRID.
- 7.4 The suggestion made by Senator Kehm was not accepted as a friendly amendment.
- 7.5 Senator Dewey suggested as a friendly amendment to make the new item #3.
- 7.6 Senator Dewey further suggested as a friendly amendment that in order to match  
the language in the existing policy the Anagnoson motion be revised to read as  
follows:  

FOR ALL GENERAL EDUCATION COURSES, THE AREA OF THE  
GENERAL EDUCATION PROGRAM THAT THE COURSE FULFILLS.
- 7.7 It was agreed by consensus to accept Senator Dewey's suggestions as friendly.
- 7.8 The Anagnoson motion was approved as amended.
- 7.9 Senator Dewey suggested as an editorial amendment that the word THE be inserted  
before the word "course" in item #1.
- 7.10 It was agreed by consensus to accept Senator Dewey's suggestion as editorial.
- 7.11 It was m/s (Anagnoson) to amend item #2 by adding the phrase WHICH ARE  
ADDRESSED BY THIS COURSE after the word "outcomes."
- 7.12 Associate Vice President Winnick suggested that the body consider adding  
the word PROGRAM before "learning outcomes" in item #2.
- 7.13 Discussion ensued.
- 7.14 The Anagnoson motion failed.
- 7.15 It was m/s/p (Cates) to amend item #2 by deleting the phrase /learning outcomes.
- 7.16 The document was APPROVED as amended (00-14). Copies of the document are
