## 1. 1.1 The Chair's Announcements:

1.1.1 As your chair for this year, it is my pleasure to welcome you to the first meeting of the 2000-2001 Senate. Welcome! It is a pleasure to be here. I have several announcements and then I will see if you have any.
1.1.2 Included in your Senate package today as information items are copies of the Parliamentary Procedures and the Miscellaneous Rules which govern Senate meetings and the membership list for the Fall Quarter. There are two additional names to add to the membership list: for the College of Arts and Letters, the alternate for David Connors will be Christophe Lagier; and for the College of Health and Human Services, the alternate for Patricia Chin will be William Franklin.
1.1.3 During the Summer Quarter, the Academic Senate considered a proposal to modify the list of Academic Administrative Positions Requiring Formal Consultation. The recommendation was sent to the Senate by the Executive Committee because the Faculty Handbook language that deals with formal and informal consultation when administrative positions are being filled and the list of administrators were in conflict. The recommendation to modify the list failed. On August 22, 2000, President Rosser sent the following memo:
"In view of the action taken by the Senate regarding the above mentioned item, I am respectfully submitting the following statement of clarification of University policy:

The chronology included the signing of three documents over a period of 8 months. The POLICY documents were signed and approved prior to the signing of the LIST document, which came to me as a separate item. As has been discussed, I inadvertently signed the List document believing that it was in keeping with the Policy document.
"Therefore, the operative document regarding positions that require formal or informal consultation will be the POLICY document."

In accordance with the President's statement of clarification, the Faculty Handbook has been corrected so that the list of academic administrators does not include the Vice President for Information Resources.
1.1.4 On October 2, 2000, President Rosser returned unsigned the Senate's proposed modification to the policy titled "Retired Faculty, Emeritus Status" and submitted a document for consideration in lieu of the proposed modification. The document submitted by the President has been agendized for the Executive Committee.
1.1.5 The CSU Office of International Programs is currently seeking CSU faculty to serve as resident directors in its 2002-2003 international programs in France, Italy, Japan, Mexico, Spain and Zimbabwe. Additional information is available in the Senate Office.
1.1.6 The Academic Council on International Programs and the CSU Office of International Programs has announced a conference scheduled to take place in June 2001 in Germany. The theme of the conference is "The New Europe and the New California: Coexistence Convergence, and Collision of Cultural Communities."
