Senator Koch raised a question regarding the University Bookstore textbook pricing policy.	
The contract between University Auxiliary Services, Inc. and Barnes and Noble College Bookstores, Inc. represents that the sale markup at the Bookstore will be as follows: New textbooks will be sold at no greater (i) the publisher's list price or (ii) a 25% gross margin on the net priced books, inclusive of restocking fees, return penalties or other surcharges. Used textbooks will be sold at 25% less than the new selling price. Course packs and textbooks purchased from publishers with restrictive, non-returnable text policies will not be priced beyond a 30% gross margin. School supplies will be priced at or below manufacturers' suggested retail prices.	
1.1.4 Following is the response from Vice President Garcia to the questions raised by Senator Burstein at the Senate meeting of January 15, 2002:	
Senator Burstein raised a question regarding the traffic design at Parking Structure II.	
In response, Parking Services is negotiating a contract with a traffic engineering consultant to review the safety concerns expressed by Senator Burstein. As an interim measure, an internal stop sign will be placed
