Former Senator Keane announced her intent to raise the following question: I am teaching two courses this quarter and my students are extremely upset because they went to the parking lot to find out that the parking lot had changed to two hour time modules. In the past, they were able to pay for half hour blocks and hour blocks; under the new format they must pay for two additional hours when they may be using only about 10 to 15 minutes of the time. It is impossible for them to get to their cars within the four-hour block unless they leave early (which faculty don't appreciate). Have we looked at the impact on our students when this is happening at the same time as fee increases and textbook costs that are extreme? Can it be turned back?
