- 1. 1.1 The Chair's Announcements:
 - 1.1.1 I am pleased to report that Marshall Cates, Department of Mathematics, has been re-elected to serve as Statewide Senator for a three-year term ending in 2008.
 - 1.1.2 On April 14, 2005, President Rosser sent the following memo regarding the Senate's Proposal for Visual Recognition of Ruben Salazar:

"I am in receipt of your memo regarding the Proposal for Visual Recognition of Ruben Salazar. As per Administrative Procedure 007, Item 5.4, requests for signage and graphics must be reviewed by the Campus Physical Planning Committee. The Committee then makes its recommendation to me. By copy of this memo, I am requesting that the Committee expedite its review and recommendation of your request."

- 1.1.2 The ASI Board of Directors has appointed Kenneth S. Lee and Miguel Reyes to serve as Postbaccalaureate Senators through Summer, 2005.

RESOLUTION OF COMMENDATION FOR WILLAM A. TAYLOR	 It was m/s/p UNANIMOUSLY (Anagnoson) to approve the following Resolution of Commendation for William A. Taylor:
	WHEREAS William A. Taylor has retired from Cal State Los Angeles after 34 years of dedicated and distinguished service to the Department, College, and University; and
	 WHEREAS He served as Professor of Physics, Associate Dean of the College of Letters and Science, Associate Vice President for Academic Affairs – Planning and Resources, Acting Vice President for Academic Affairs, and, most recently, as Chair of both the Academic Senate and the Department of Physics and Astronomy; and
	WHEREAS He was known as Associate VPAA for the "black hole" into which all documents sent to the 7 th floor of the Administration building eventually fell, something we attributed to his background as a physicist, only to find when he left that position that every occupant of every office on the 7 th floor of the Administration building had his or her own "black hole"; and
	WHEREAS He began a number of innovative programs for students of the sciences, including designating CSULA as the first public university campus to host the Southern California Conference on Undergraduate Research, and co- founding the University Preparatory Program, established in 1989 to increase the number of underrepresented minority students who major in science- and mathematics-based fields; and
	WHEREAS He has taught 44 different courses and laboratories over his 34 year career, supervised many students in their graduate work, and was principal or co- principal investigator for grants totaling more than a million dollars; and
	WHEREAS He assumed with reluctance the position of Chair of the Academic Senate, fulfilling from 2000 to 2002 that position with the same level of competence, integrity, and wisdom that characterized his former administrative positions, although we note that he dealt entirely too much during his term with issues of "accountability measures"; and

- WHEREAS While Chair of the Academic Senate, he co-chaired the task force that produced the single most important document produced in the last decade on the future of the faculty at Cal State Los Angeles, the "Faculty Utilization Report," wherein three faculty and three administrators agreed unanimously that the campus needed to have substantially more full-time tenured and tenure-track faculty; and
- WHEREAS He received the Cal State L.A. Outstanding Professor Award for 2001-2002, and was cited for his "leadership and commitment to academics," preceded by his election as "Faculty of the Year" by the CSULA Associated Students, Inc., in 1998; therefore, be it
- RESOLVED That the Academic Senate of California State University, Los Angeles, honor William A. Taylor on the occasion of his retirement from the California State University, express to him its sincere thanks for his absolutely outstanding and dedicated service on both the 3rd and the 7th floors of the Administration building, and extend its best wishes to him in his new occupation of antique shop proprietor, not to mention prospective Chair of the Department of Physics and Astronomy.
