- 1. 1.1 The Chair's Announcements:
 - 1.1.1 Welcome to the first Senate meeting of the quarter. I look forward to working with you this year.
 - 1.1.2 I am pleased to report that Ted Anagnoson_has agreed to serve as Parliamentarian this year. The Senate document summarizing the parliamentary procedures and the document on Miscellaneous Rules are available in the public folders under "Academic Senate."
 - 1.1.3 On September 5th we received the following memo from President Rosser regarding renaming DALSA: "I have received your request to rename the Division of Administration, Library and Student Affairs (DALSA). In the request you express a desire to have the title accurately reflect the composition of the faculty in that unit. I have determined that the name will be revised to Library and Student Affairs effective Fall Quarter, 2007."
