All University Web pages must have a "Page Master" who is responsible for the content of the Web page. The unit/office page masters are Deans, Department Chairs, office Directors or their designees. Therefore, Deans and Department Chairs are responsible for determining when outdated faculty pages are removed from the Web sites.</li> <li>PUBLIC FOLDERS Yes, however, cleanup is the folder owner's responsibility. Individuals or departments requesting a Public Folder must submit an Outlook <sup>TM</sup> Public Folder. By signing the form, available at www.calstatela.edu/its/forms. The form also provides a checkbox for deletion of an existing folder. By signing the ford* Acknowledgement of Appropriate Use of Account statement, the "folder owner agrees to delete non-relevant or outdated items from the Outlook <sup>TM</sup> Public Folder." More folder owner responsibilities are explained in the <i>User Guidelines for Outlook</i> <sup>TM</sup> Public Folders, available at www.calstatela.edu/its/policies.   - 3.2 Senator Zepeda indicated that in the fifth line of item 1.1.3 the word "of" should be deleted.
  - 3.3 The minutes were approved as corrected.
- 4. It was m/s/p Bowman to approve the agenda.
- 5. 5.1 It was m/s/ (Dewey) to amend line 55 of document 07-8 by inserting the phrase IN A TIMELY MANNER after the word "President."
  - 5.2 Senator Faust suggested as a friendly amendment inserting the phrase IN A TIMELY MANNER on line 54 after the word "forwarded."
  - 5.3 It was agreed by consensus to accept the Faust amendment as friendly.
  - 5.4 The recommendation was APPROVED UNANIMOUSLY as amended (07-8). Copies of the document are available in the Senate Office.
  - 5.5 It was m/s/p (Bowman) to forward document 07-8 to the President in advance of the approval of the minutes.
- 6. 6.1 It was m/s/ (Zepeda) to change the name of the award to the Outstanding LECTURER Award.
  - 6.2 Senator Novak asked if the intent of the motion was to change the name of the award throughout the document.
  - 6.3 Senator Zepeda confirmed that it was the intent of the motion to change the name of the award from <u>Teaching</u> to LECTURER throughout the document.
  - 6.4 The motion was approved.
  - 6.5 Debate continued and it was agreed by consensus that changing the title of the award from "Outstanding Teaching Award" to "Outstanding Lecturer Award" would not exclude librarians from being eligible for the award.
  - 6.6 It was m/s/ (Yorker) to amend line 13 of document 07-9 by inserting the phrase AND MUST HAVE TAUGHT FOR THE LAST SIX ACADEMIC YEARS AT CSULA after word "level."
  - 6.7 Senator Beer suggested as a friendly amendment deleting the word <u>for</u> and Inserting the word DURING.
  - 6.8 It was agreed by consensus to accept the Beer amendment as friendly.
  - 6.9 Senator Bowman suggested as a friendly amendment changing <u>during the last six</u> <u>academic years</u> to AT LEAST NINE QUARTERS.
