- 6.13 It was m/s/ (Flint) to amend lines 46 and 47 of document 07-11 by deleting the words other than credential programs.
- 6.14 Debate ensued.
- 6.15 It was m/s/p (Dewey) to close debate on the Flint amendment.
- 6.16 The motion was approved.
- 6.17 It was m/s/p (Flint) to amend document 07-11 by deleting the words <u>candidates for</u> at the end of line 61, adding an "S" to "TA" at the end of line 61, and deleting the word <u>positions</u> at the beginning of line 62.
- 6.18 It was m/s/p (Peterson) to amend the last paragraph of document 07-11 by replacing the word "quarter" with TERM.
- 6.19 The recommendation was APPROVED as amended (07-11). Copies of the document are available in the Senate Office.
- 7. 7.1 It was m/s/ (Flint) to amend line 5 of document 07-12 by inserting the parenthetical phrase (8TH WEEK OF THE SUMMER QUARTER) before the word "preceding."
 - 7.2 Senator Falvey suggested as a friendly amendment that the Flint motion be changed by deleting the words of the 5th week of the quarter preceding and inserting the words SEVEN WEEKS PRIOR TO THE FIRST DAY OF.

 - 7.5 It was m/s/ (Reed) to amend document 07-12 by inserting the statement: IF THE ORDERED TEXTBOOK IS NOT AVAILABLE OR PROVES TO BE UNSUITABLE FOR THE COURSE THE FACULTY MEMBER TEACHING THE COURSE SHALL MAKE EVERY REASONABLE EFFORT TO MAKE SURE THE STUDENTS WITH DISABILITIES HAVE ACCESS TO WHATEVER TEXTBOOK IS TO BE USED.
