1.1.4	On August 13, 2008, President Rosser returned unsigned the proposed policy titled "Outstanding Lecturer Award." His memo reads: "I am returning the above titled proposed policy to you unsigned. I am not opposed in principle to the recognition of outstanding temporary faculty members and might be inclined to support such a policy that limited eligibility to long-term temporary faculty (such as those who have taught here for at least two quarters per year for six consecutive years)."
