			<i>Question:</i> "What steps has the University taken to reduce our overall carbon footprint, from 2008 levels."	

ANNOUNCEMENTS (Continued)

Response:

"Projects completed, under design, or being evaluated to reduce our carbon footprint are:

- The study and redesign of the campus' Central Plant. This has been done through a process known as Monitoring Based Commissioning. Over 25% of the total campus carbon footprint is directly attributable to the building air-conditioning and heating systems. The result of this project plus two similar projects in King Hall and the Administration building in the preceding year have resulted in the avoidance of 1,303 metric tons of greenhouse gas.
- Replaced the window film on the south side windows of King Hall, Fine Arts, Salazar Hall, PE, and Music as well as replaced the window coverings on all windows in the following buildings: King Hall, Biological Sciences, Simpson Tower, Salazar Hall, and Fine Arts. These improvements reduce the heat load which reduces cooling demands, thereby diminishing the carbon footprint.
- Recycling of waste materials; Utilization of recycled products; and Use of sustainable cleaning products.
- The campus has entered into an agreement to install approximately 500 kilowatts of photovoltaic power on campus. The photovoltaic panels will be placed on the roofs of Salazar Hall, the Physical Education building, and Fine Arts. This project is currently scheduled to be completed by the 4th quarter of 2010.
- A project is being evaluated that would develop new photovoltaic cell and battery power systems in Parking Structures A and C to power LED lighting that would be installed in the structures, removing these structures from reliance on fossil fuel generated power.
