1.1.1	I am pleased to report that Greg Andranovich, Department of Political Science, has been elected by the Academic Senate to serve on the Intercollegiate Athletics Board for a four-year term ending in Summer Quarter, 2013.			
1.1.2	Following is the response from Vice President Ross to the question raised by Senator Hunt at the Senate meeting on April 28 <sup>th</sup> :			
	<i>Question:</i> University policy (2007-09 CSULA Catalog) states, "Students who fail to take and pass the WPE within the required time limit of 135 units will have a hold placed on their records, which will preclude them from enrolling in any courses until the WPE requirement is satisfied." The Department of Child and Family Studies has received funding from Los Angeles Universal Preschool to closely track and monitor the progress of transfer students pursuing careers in early childhood education. In overseeing this effort, it has come to our attention that some students, admitted in Summer of 2008, have neither attempted nor passed the WPE.			
	My question is: Why is the University not enforcing this important policy? This policy is one of our important early warning signs regarding student progress and its enforcement will assist students to reach their degree goals in a timely and efficient manner.			
	<i>Response:</i> The University does enforce the WPE Policy. Each quarter the Testing Center receives a report that lists all students with 135 units who have not taken and/or passed the WPE and places a hold on their record preventing them from registering for any future term until they have passed the exam.			
	The Testing Center also sends warning letters to students with less than 135 units earned but more than 90 units earned informing them of the WPE requirement and encouraging them to register for the exam as soon as possible.			
	If the department or Senator(s) is aware of students who have come to their attention as not having met the WPE requirement and who have been allowed to continue to register for classes, I ask that they provide me (Ross) with the names and CIN's of those students and I will request the Testing Center Coordinator to review their individual situations and place the appropriate hold if needed.			
	Thank you for the opportunity to respond and I trust this addresses Senators Hunt and Zepeda's question.

1.1.5 Provost Cardoza and I have been tweaking an email that will soon be sent to all faculty. It will explain the formation of a Planning or Steering Committee for the possible conversion to semesters. This committee will be charged with studying in detail the processes and costs involved in the possible conversion. These will include, for example, the process and costs for converting curriculum, for advising students caught in the transition, for adapting student services to semesters, and other issues of equal significance and import.

The committee will have representatives from each college and the Library. These representatives will be elected by the faculty. They will start to work this summer and will serve on the Planning Committee and as a member and liaison to a workgroup. They will receive reassigned time during the 2009-2010 Academic Year. The Senate will also elect two at-large representatives and the Senate Chair will serve on the Steering Committee as will all of the Vice Presidents.

Next spring the committee will issue its report. At that time the Senate will consider again the advice it wishes to give to President Rosser. I remind you, that last week the President made it very clear that the decision has not been made, that the costs and processes must be detailed thoroughly in order for him to make a sound decision. The Planning Committee's work is a crucial aspect of that decision making.
