R. Land convened the meeting at 1:35 p.m.

- 1. 1.1 The Chair's Announcements:
 - 1.1.1 On January 22, 2010, President Rosser returned unsigned the Academic Senate's proposed modification to the Policies and Procedures for Academic Program Discontinuance, <u>Faculty Handbook</u>, Chapter IV. The memo reads:

"I am returning the above titled proposed policy modification unsigned. First, the proposed policy modification VI. does not contain a clear definition of suspension. In addition, the procedures only provide information for when the request for suspension comes from tenured and tenure-track faculty of the department/division/school in which the program is housed and this conflicts with section III.A.I. It also is not clear what the review and decision process entails and who initiates the administrative actions that must be taken. Part V. of the policy addresses only discontinuance. There also needs to be a specified review and approval process before an early reactivation process is initiated. If the maximum suspension duration is three years, why is there a statement regarding extension of the suspension? Given the last sentence of section IVA., perhaps it would be more suitable to have two policies and procedures – one for temporary suspension and one for discontinuance."

The officers met with the Provost yesterday on this issue and it is on the Executive Committee's agenda for tomorrow's meeting. This can be discussed in some more detail during the Chair's report on today's agenda.
