PROPOSED POLICY: POLICIES AND PROCEDURES FOR TEMPORARY SUSPENSION OF ACADEMIC PRO-GRAMS, <u>FACULTY HANDBOOK</u>, CHAPTER IV (09-9, <u>-9.1</u>) Second-Reading 6. Chair Land presented his report.

- 7. 7.1 Senator Moss distributed document 09-9.1.
 - 7.2 It was m/s/ (Moss) to amend document 09-9 by inserting the first three paragraphs from document 09-9.1.for the language on lines 5 through 16.
 - 7.3 Senator Baaske suggested as a friendly amendment that the words TENURED AND TENURE TRACK be inserted on the second sentence in the third paragraph of document 09-9.1.
 - 7.4 It was agreed by consensus to accept the suggestion made by Senator Baaske as a friendly amendment.
 - 7.5 It was m/s/p (Cleman) to delete the second sentence in the third paragraph of document 09-9.1.
 - 7.6 It was m/s/p (Izquierdo-Edler) to amend document 09-9.1 by reversing the first and second paragraphs.
 - 7.7 It was m/s/ (Dumitrescu) to amend document 09-9.1 by deleting the first sentence from the third paragraph and inserting it on line 31 of document 09-9.
 - 7.8 The Chair ruled Senator Dumitrescu's motion out of order at this time.
 - 7.9 The Moss motion to amend document 09-9 by inserting the language from document 09-9.1 failed.
 - 7.10 It was m/s/p (Classen) to amend document 09-9 by inserting the two statements defining program suspension in the second paragraph of document 09-9.1.
 - 7.11 It was m/s/p (Cleman) to amend document 09-9 by inserting on line 22 the statement that defines program faculty, the first sentence in the third paragraph on document 09-9.1.
 - 7.12It was m/s/ (Allison) to amend line 11 of document 09-9 by deleting the word in order to reactivate and inserting the words FOR POSSIBLE REACTIVATION OF.
 - 7.13 Senator Flint suggested as a friendly amendment to the Allison motion that word <u>reactivation</u> be changed to REINSTATEMENT.
 - 7.14 It was agreed by consensus to accept Senator Flint's amendment as friendly.
 - 7.15 The Allison motion failed.
 - 7.16 It was m/s/ (Andre-Bechely) to amend document 09-9 by inserting the following statement on line 31: ALL CONSULTATION CONCERNING PROGRAM SUSPENSION MUST BE DOCUMENTED.
