Dr. Petersen helped guide the University of Tennessee through major changes in academic programs at a time of significant budgetary problems. - 7.6 Senator Dewey suggested, and it was agreed by consensus, that the minutes reflect the Senate's intention that implementation of the suspension of the Transition to Cal State L.A. as a University requirement would be accomplished administratively and not require faculty to submit a course substitution for each student.
