	<u>Answer:</u> The February16 release from my office may be found on the Public Affairs webpage.	
	Stories were published in the <i>Jewish Journal</i> and <i>Pasadena Star News</i> . Additionally, a story about Mr. Leyson is already written and already in layout format for the upcoming issue of <i>Cal State L.A. Today</i> magazine going to press in May. Other outreach included a notice on Public Affairs' Cal State L.A. Today Facebook page, a flyer, poster, University calendar posting and electronic sign information.	
	<u>Question:</u> Why did the University not publicize its connection to Jaime Escalante upon his death?	
	<u>Answer:</u> The Office of Public Affairs respects family wishes at such a time. The family chose to focus attention on the high school where Mr. Escalante spent his career teaching. Public Affairs, however, responded to many media calls regarding his alumnus status and CSU honorary degree, including from the <i>NewYork Times</i> and <i>Los Angeles Times</i> . 1.1.3	Following is the response from University Librarian Alice Kawakami to the Question raised by Senator McQueen at last week's Senate meeting:

"In regards to the question posed at this week's Senate Meeting regarding access to libraries at USC, their library administration confirmed the information below. I have also included information about UCLA libraries.

"University of Southern California Libraries: Students, faculty and staff from local colleges and universities may apply for a reduced fee at the rate of \$25.00 for 6 months for currently enrolled students, and \$50.00 for 6 months for currently employed faculty and staff. (The regular fee for individuals who live in the LA area is \$125.00 for 6 months.) All applications are subject to review for approval.

"UCLA Libraries: Free Library cards will be issued to Faculty from accredited institutions of higher education in the state of California with current, government-issued photographic identification and appropriate proof of status. Users are limited to borrowing five books at a time.

"Please let me know if you have any questions."

1.1.4 At last week's Executive Committee meeting, faculty governance for the Summer was discussed and it was agreed by consensus that it would not be feasible to elect a Summer Senate from among the limited number of faculty on duty this Summer.

It was also agreed by consensus that the current members of the Executive Committee would continue to serve through the remainder of their terms ending Summer even if not on duty because there will not be a Summer Senate from which to elect alternates.
