2. 2.1 Senator Monroy announced her intent to raise the following question:

What happened to the \$71,000 of fees that were sent to the Administration?

2.2 Senator Land announced his intent to raise the following question of the Vice President for Student Affairs:

As background: October 7th, 2011, a memorandum from the registrar announced that because the campus was at 108% of its enrollment target for the Fall quarter, paper adds would not be accepted as they normally are during the days before census. Announced in advance, chairs and other faculty could have adjusted their schedules to make sure they could meet the needs of students while managing limited instructional resources.

The question is: Why is exceeding target enrollment for one quarter such a problem that it justifies abrupt interference with normal faculty activities?

2.3 Senator Dumitrescu announced her intent to raise the following question:

When am I going to receive a response to the two questions raised on May 24th?

- 3. It was m/s/p (Classen) to approve the minutes of the meeting of October 4, 2011 (ASM 11-2).
- 4. It was m/s/p (Falvey) to approve the agenda.
- 5.1 Senator Klein suggested as a friendly amendment that the second "Resolved" clause of document 11-1 be amended by inserting the words AS APPROPRIATE FOR INDIVIDUAL STUDENTS after the word "waivers."
 - 5.2 Senator Klein's s amendment was not accepted as friendly.
 - 5.3 Senator Bowman suggested as an editorial amendment to document 11-1 that the reference to "60 units" be changed to "90 quarter units" throughout the document.
 - 5.4 It was agreed by consensus to accept Senator Bowman's suggestion as an editorial amendment.
 - 5.5 Senator Bell suggested as a friendly amendment to document 11-1 that the phrase For reasons not fully explained be deleted from the sixth "Whereas" clause.
 - 5.6 Senator Bell's suggestion was not accepted as a friendly amendment.
 - 5.7 It was m/s/f (Momand) to amend the first "Whereas" clause of document 11-1 by deleting the word <u>blanket</u> and inserting the words CHANCELLOR IMPOSED.
 - 5.8 The resolution was APPROVED UNANIMOUSLY.
