1. 1.1 The Chair's Announcements:

1.2 The Vice Chair's Announcements

- 1.2.1 Last week it was announced in error that Gretchen Peterson had been elected by the Nominations Committee to serve on the Intercollegiate Athletics Board for a four-year term ending Summer, 2016. The title of of the speech is "Natural Partnership: Korea-U.S. Opportunities and Challenges." The time is May 1st, from 3:15 to 5:00 p.m., which includes the speech, questions and answers, and a reception. It will be held at the Golden Eagle, Ballroom #3.

This event is made possible by the concerted efforts of the Center for Korean American and Korean Studies, the Korean Language Program of the Department of Modern Languages and Literatures, the Korean Student Association, the Office of Institutional Development, the Natural and Social Sciences Dean's Office, the Office of the Provost, and most importantly the Office of the President

This event will mark an epoch collaboration and building of a close relationship between Cal State L.A. and the Korean government. The Korean government has already funded about \$800,000 to Cal State L.A. to establish Korean minor, major and teaching credential programs. We hope this event will strengthen the relationship.

1.4 Senator Dumitrescu announced: I have a message from Professor Cantu.
"I am very pleased to invite you to the 2012 Conference on Carlos Fuentes that will take place this coming May 4th and 5th at Cal State L.A.'s Golden Eagle Ballroom. This conference brings to our campus five keynote and featured speakers and panelists from Belgium, England, France, Germany, Japan, Korea, Mexico and the United States to speak on the work of Carlos Fuentes. Cal State L.A. students, staff, and faculty will be participating, presenting papers, or moderating sessions. The two-day conference program includes speakers in five sessions on the work of Carlos Fuentes, one session on Mesoamerica (a book presentation), and a fully staged play adapted from Carlos Fuentes' *Oriquideas a la luz de la luna (Orchids in the Moonlight)*, with Mexican actresses Alejandra Flores and Cristal Gonzalez playing the roles of Maria Felix and Delores del Rio, respectively.

"Please invite your friends and colleagues on other campuses, and urge your students to attend. This conference, including the play, is free and open to the public."

1.5 Senator King announced: As everybody probably knows, CFA is having a vote on whether or not to strike this week. We have a table outside the Library until the end of the week and you can still vote online. The best way to prevent a strike is to prepare for one.

Next Wednesday CFA has invited an accountant from Eastern Michigan University to talk to us about budgets, putting an emphasis on Cal State, L.A.'s budget – how the money is being spent and answering questions about it. He is President of the AAUP Collective Bargaining Conference so he does this at universities around the country. Howard Bunsis is his name and he will be here next Wednesday, 3:00 to 5:00 p.m. in the Applied Gerontology Institute. I am going to pass this flyer around for everybody.

- 1.6 Senator Dewey announced: Norman Fruman, who was a Professor of English and a long-time member of the Senate during his thirty years on campus, has died. Norman was suffering from cancer for many years and it did not come as a surprise.
- 2. Senator Aniol announced his intent to raise the following questions on behalf of the Educational Policy Committee of the College of Natural and Social Sciences:

The department of Biological Sciences is proposing to offer a two year completion to the B.S. Biology Degree at the College of the Canyons in Santa Clarita. The proposed program will be offered through CSULA's College of Extended Studies and International Programs (CESIP) under what is termed "special session" and thus will not be supported by state money.

- 1) What will be the curriculum approval process for programs offered through CESIP? For example, will NSS EPC have primary responsibility for curriculum approval of the proposed degree and any future modifications to it?
- 2) Students enrolled in CESIP programs will pay substantially more than regularly matriculated students. How will the extra revenue be distributed? For example, in this case will the Biological Sciences Department receive extra funds? If so, what is the formula for the distribution of funds between the various parties (the College of the Canyons, CESIP, the CSULA Department of Biological Sciences, etc.)?
- 3) Will CESIP be able directly to hire faculty to support the degree programs it offers or will hiring be made by the departments that offer the equivalent degree program in one of the state-supported colleges at CSULA?

4) If CESIP is able to hire faculty to teach in the degree programs it offers will these faculty be covered by the CSU/CFA faculty contract and the CSULA *Faculty Handbook* with the same rights and responsibilities as faculty who teach in the academic colleges of CSULA?

 - COMMITMENT TO THE FACULTY VOICE IN ANY REVISIONS/ MODIFICATIONS TO UNDERGRADUATE AND GRADUATE EDUCATION PROGRAMS IN RECOGNITION THAT THE FACULTY IS ESSENTIAL IN DETERMNING THE CURRICULUM. Any criteria employed in such decision-making shall be determined in an open and transparent manner and published for easy access by the University community.
 - 6.6 It was m/s/f (Flint) to continue this item as second-reading at the next meeting.
