11. 11.1 It was m/s/ (Warter-Perez) to amend document 12-11 by amending lines 1 to 3 as follows: CSULA grants students lower-division baccalaureate AND upper division baccalaureate and graduate degree nonresident credit toward UNDERGRADUATE admission eligibility and toward the baccalaureate degree for the types of formal instruction in noncollegiate settings, either military or civilian, recommended by the American Council on Education, and by inserting the following statement on line 12 after the word "education": CSULA GRANTS STUDENTS GRADUATE ADMISSION ELIGIBILITY FOR THE TYPES OF FORMAL INSTRUCTION IN NONCOLLEGIATE SETTINGS, EITHER MILITARY OR CIVILIAN, RECOMMENDED BY THE AMERICAN COUNCIL ON EDUCATION.
- 11.2 It was m/s/ (Peterson) to substitute a motion to amend the first sentence of document 12-11 so that it would read: CSULA GRANTS STUDENTS LOWER-DIVISION BACCALAUREATE AND UPPER-DIVISION CREDIT TOWARD ADMISSION ELIGIBILITY AND THE BACCALAUREATE DEGREE AND GRADUATE DEGREE CREDIT TOWARD ADMISSION ELIGIBILITY FOR THE TYPES OF FORMAL INSTRUCTION IN NONCOLLEGIATE SETTINGS, EITHER MILITARY OR CIVILIAN, RECOMMENDED BY THE AMERICAN COUNCIL ON EDUCATION.
- 11.3 It was m/s/ (Warter-Perez) to refer document 12-11 back to the Educational Policy Committee for clarification.
- 11.4 Senator McAllister suggested that the Educational Policy Committee be asked to look at the "may," "should," and "shall" issues which this is trying to address.
- 11.5 The motion to refer document 12-11 back to the Educational Policy Committee passed.

12. 12.1 It was m/s/ (Warter-Perez) to refer document 12-12 back to the Educational Policy Committee for clarification of the faculty role in granting credit in the major or General Education.
- 12.2 Discussion ensued and it was recommended that EPC clarify that the *program* faculty will determine how those units will be used within the major.
