1. 1.1 The Chair's Announcements:

1.1.1 Following is the response from Provost Vaidya to the question raised by Student Senator Antezana at the Senate meeting of January 15, 2013:

Ouestion:

Who is to blame for the shortage of classes?

Response:

The supply of classes available to students is limited by the University's enrollment cap which is set by the Chancellor's Office, and state funding for instruction.

For the 2012-13 college year, the University will achieve 105% of its enrollment target. We have exceeded our budgeted FTES target for the year, and cannot provide additional classes. In order to meet excess demand, we are offering additional special session classes through the College of Extended Studies and International Programs.

1.1.2 Following is the response from Vice President Chavez to the question raised by Senator Ledesma at the Academic Senate meeting on January 15, 2013:

Ouestion:

Is it possible to clean the keyboards, mice and tables in the tech rooms on campus?

Response:

Keyboards and mice in the tech rooms are cleaned before the start of each quarter by ITS. Additionally, the tables, keyboards and mice in the tech rooms are expected to be cleaned on a regular basis by the custodians assigned to each area of the buildings.
