PROPOSED POLICY REVISION: DEFINITION, PHILOSOPHY AND CRITERIA FOR GENERAL EDUCATION BREADTH REQUIREMENTS, <u>FACUL-TY HANDBOOK</u>, Chapter IV (13-3) Second-Reading

- 7. 7.1 The chair reminded the body that the motion (Soldatenko) to amend lines 224 and 226 of document 13-3 by changing "DIVERSITY" to "RACE, ETHNICITY, GENDER AND SOCIOECONOMIC CLASS" was on the floor.
  - 7.2 Senator Soldatenko made a request to change the language of his motion and objections were raised.
  - 7.3 It was m/s/p (Soldatenko) to amend the motion by inserting the words on line 227 after the word "catalog": THE INTERSECTIONALITY OF GENDER, RACE, ETHNICITY, AND SOCIOECONOMIC CLASS SHALL BE SUBSTANTIALLY INCORPORATED TO THE EXTENT POSSIBLE INTO GE COURSES (32/17).
  - 7.4 The Soldatenko motion was approved as amended (34/15).
  - 7.5 It was m/s/ (Abdullah) to amend line 227 of document 13-3 by inserting the words AT LEAST ONE OF THE TWO REQUIRED DIVERSITY COURSES MUST BE TAKEN IN ONE OF THE FOUR ETHNIC/AREA STUDIES DEPARTMENTS/ PROGRAMS: ASIAN/ASIAN AMERICAN STUDIES, CHICANO STUDIES, LATIN AMERICAN STUDIES, OR PAN-AFRICAN STUDIES after the word "courses."
  - 7.6 Senator Abdullah suggested as a friendly amendment inserting the words INCLUDING ALL COURSES THAT ARE CROSS LISTED WITH THE AFOREMENTIONED DEPARTMENTS/PROGRAMS after "Pan-African Studies."
  - 7.7 Senator Abdullah's suggestion was not accepted as a friendly amendment.
  - 7.8 Debate ensued.

7.9 It was m/s/p (Flint) to close the debate (34/16).

7.10 It was m/s/f (Abdullah) to move to a roll call vote on motion to close the debate (11/38).

7.11 The motion (Abdullah) to amend line 227 of document 13-3 failed (20/29/1).

8. It was m/s/p (Hunt) to adjourn at 3:10 p.m.
