- 1. 1.1 Chair's Announcements:
 - 1.1.1 Welcome back to Spring 2017. I hope you had a great break.
 - 1.1.2 Thank you to the immediate past chair, Nancy Warter-Perez, for her service to the Academic Senate and shared governance. Chair Prabhu yielded the floor to past chair, Nancy Hunt, who also thanked Nancy Warter-Perez.
 - 1.1.3 President Covino sent the following message to the campus:

Dear University Community:

I am writing to reaffirm the statement issued earlier today by Chancellor White and the CSU Presidents regarding the executive order issued this weekend by President Trump.

For many in our community, this executive order has caused fear and uncertainty. I want to assure you that we value our international students, faculty and staff; they are a vital part of the Cal State LA community. Their safety and well-being, and that of their families, is of utmost importance.

We are assessing the impact of the executive order on our community. For now, we recommend that students, faculty and staff from the countries included in the executive order, and anyone who feels uncertain about international travel, remain in the United States and seek the advice of an immigration attorney. We will provide updates as information becomes available.

Cal State LA does not support measures that undermine the values of our community. We pride ourselves on our unity and our diversity.

1.1.4 Chancellor White issued the following message jointly with CSSA President Lopez, Christine Miller and all 23 campus presidents:

The California State University is committed to being an inclusive and welcomeing institution of higher education that is enhanced by the students, faculty, staff and alumni from our global community.

We are deeply troubled by President Trump's recent executive order that stands in stark contrast to the fundamental tenets of the California State University. We believe in the free exchange of ideas globally, central to which is our ability to welcome and interact with those from around the world.

When something threatens our ability to think beyond our borders and learn from the world as a whole, we will oppose it. When something impacts anyone in our CSU community – especially the most vulnerable – it impacts us all. Therefore, we oppose the divisiveness of the recent executive order, and we stand with state and national officials in requesting that the President reconsider this policy.

 - Amy Gutman, president of the University of Pennsylvania, on President Trump's executive order on immigration. The university had previously shied away from publicly criticizing Mr. Trump, an alumnus of the institution.

- 1.1.11 On November 30, 2016, President Covino returned unsigned the Proposed New Policy: Graduate Studies Subcommittee advising he would approve the policy with the following changes:

Line 7: after the word "studies" add "and PaGE"

Line 13: add the following sentence "Policies concerning PaGE include but are not limited to applicability of extension credit to graduate degree programs and offering regular courses and graduate programs through PaGE."

Line 18: after the phrase "graduate studies" add "and PaGE."

At its meeting on December 1, 2016, the Executive Committee approved by Executive Action the recommended changes with the following amendment to lines 7 and 18: GRADUATE COURSES AND/OR PROGRAMS OFFERED BY PAGE.
