- 1. 1.1 Chair's Announcements:
  - 1.1.1 In regards to Senator Aniol's Concern from the floor raised at our last meeting, here is the response: The university community must migrate all legacy websites to Drupal in order to be complaint with ADA regulations that promote accessibility for all members of our campus community. All faculty members with legacy websites were contacted via email earlier this semester. The migration to Drupal does not need to be completed by December 1. Faculty will be able to continue using their legacy accounts through the end of Fall 2016 finals week if they need to delay migration until then. However, they will not be able to use their legacy sites for future terms, as these sites will be archived as of January 16th, 2017. They should make arrangements to work with their college ITCs for assistance in migrating their materials to Drupal. Thank you for your help in ensure equal access for our campus community.
  - 1.1.2 Also, we've added to the Academic Senate website two documents under the menu item: Robert's Rules of Order. The first document is more like a cheat sheet and the second document is more like an overview of Robert's Rules and Parliamentary Procedures.
  - 1.2 Senator Cleman announced: I am saddened to have to report that Emerita Professor of Physical Education, Joan Johnson, passed away this past weekend after a brief illness. She taught for many years at Cal State LA, and in 1959 helped create and then coached the first women's tennis team on campus. Most notably she was Billy Jean King's coach at that time. She was a member of the Emeriti Association and at the time of her death served on the Editorial Board for The Emeritimes. No memorial service has been announced at this time, but there will be one, and I will provide that information when it comes.
  - 1.3 M. Willard (Center for Engagement, Service and Public Good) announced: With the November 8 election drawing near it is important to provide students with opportunities to engage with voting and elections.
